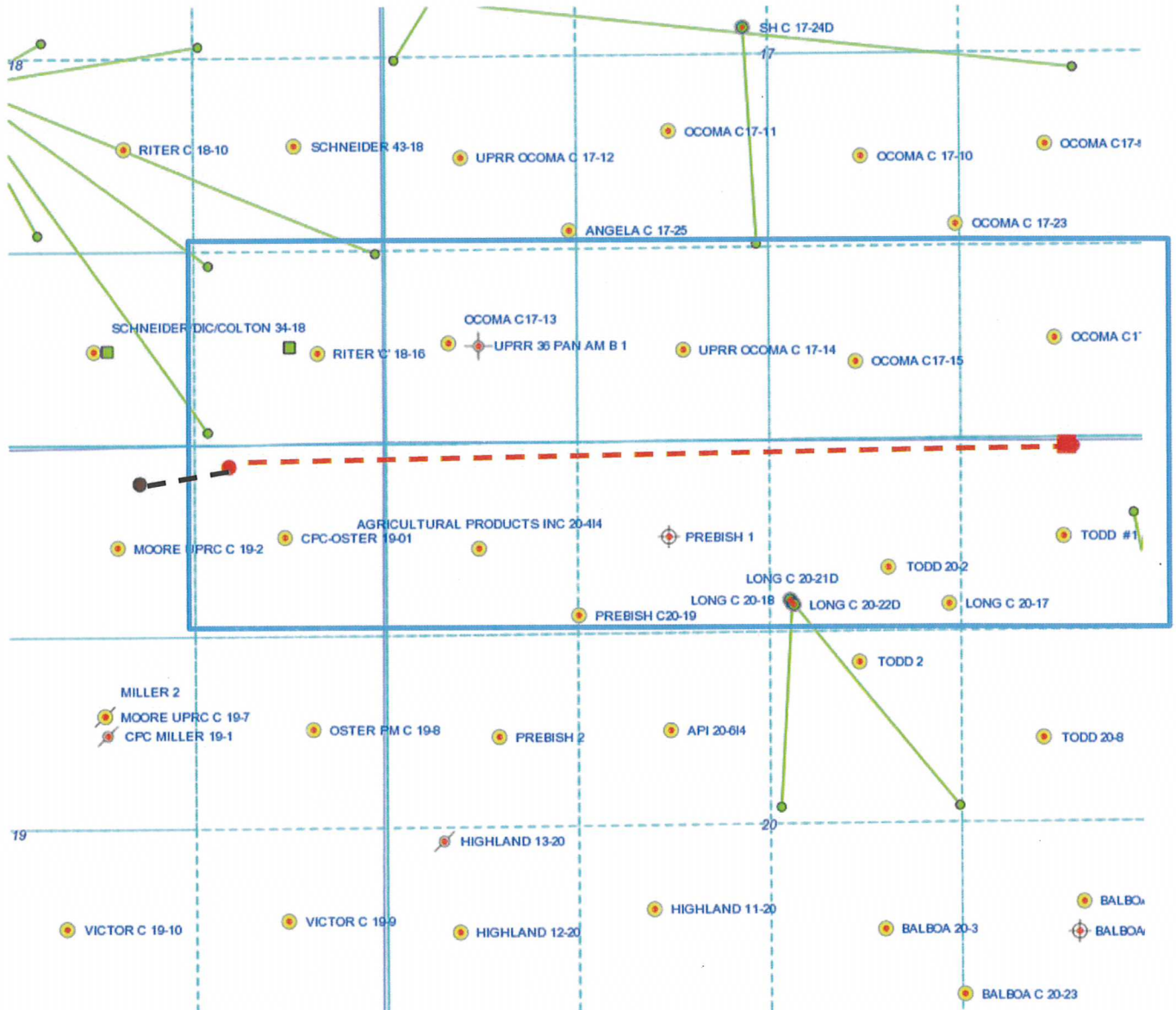

Proposed 400 acre spacing unit

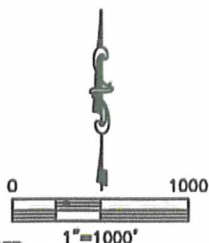
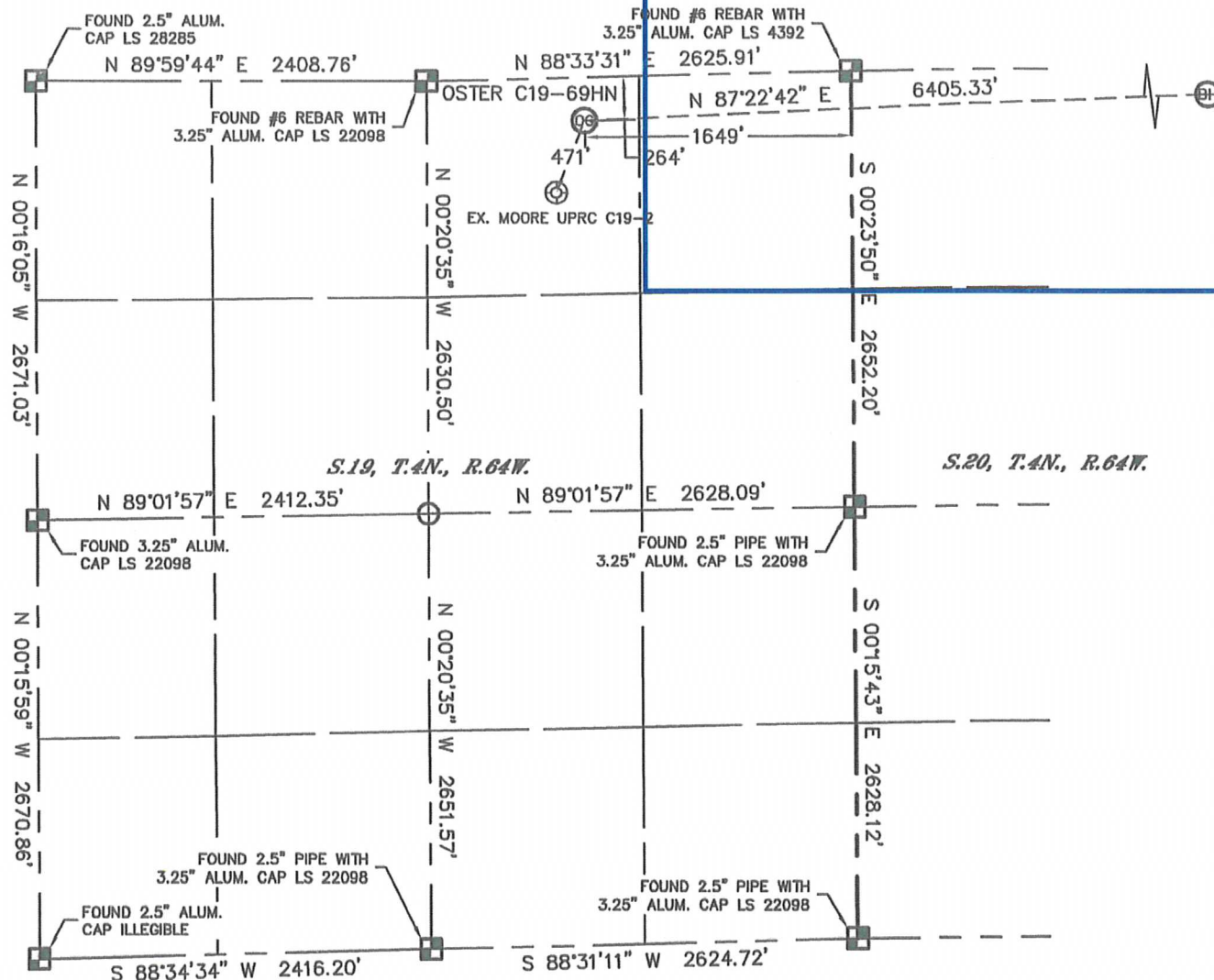


Bottom Hole Location

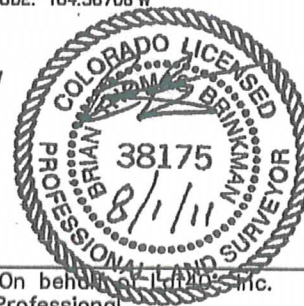

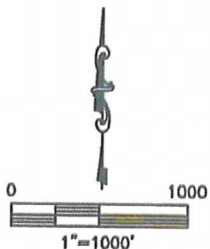
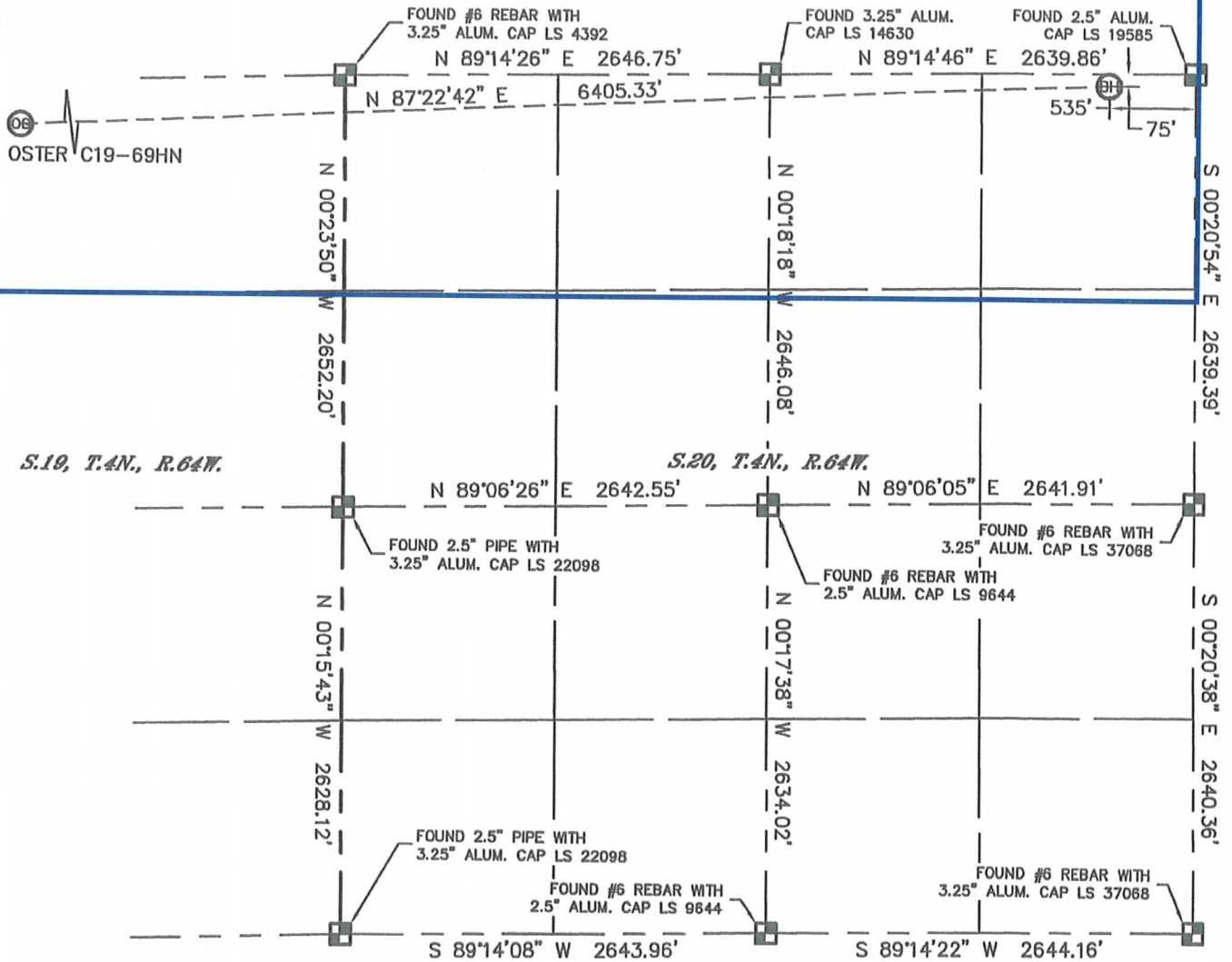
