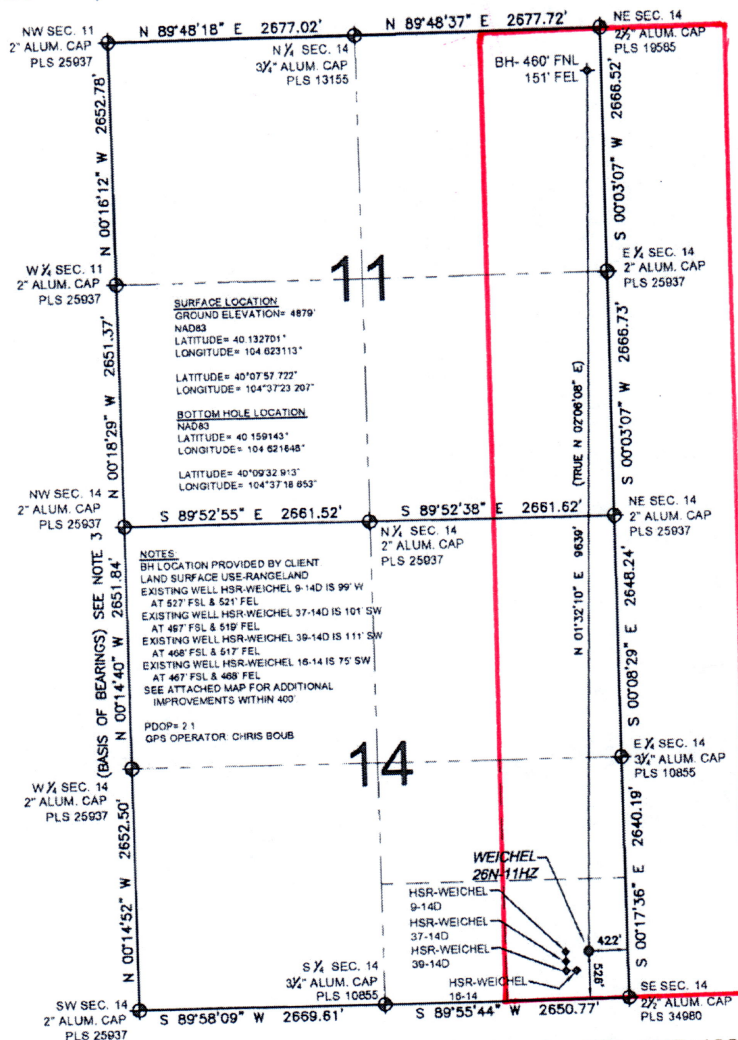

WELL LOCATION CERTIFICATE: WEICHEL 26N-11HZ

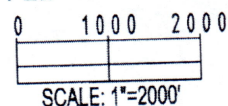

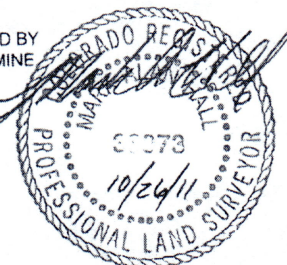

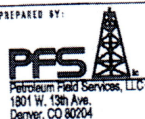
