The COGCC is reviewing the Form 2A (#400253395) for the Natural Resources Group Kayla 1 location, located in the SENW Sec 4 T34S R62W Las Animas County, Colorado. The COGCC requests additional information prior to passing the Oil and

Gas Location Assessment (OGLA).

Distance to surface water

A review of aerial photos and topographic map available on the COGCC website indicate that there is a small intermittent drainage located approximately 240 feet south east. The distance to surface water is required to be amended to 240 feet prior to passing the 2A process.

Reference area photos

The stated land use for the location is Rangeland therefore reference area photos and reference area map are required. The reference area photos need to be taken of an area that will not be disturbed during oil and gas development and near the proposed location. The location photos cannot be used as reference area photos.

Rule 303.d(3)F ii describes the requirements for the reference area map and photos.
