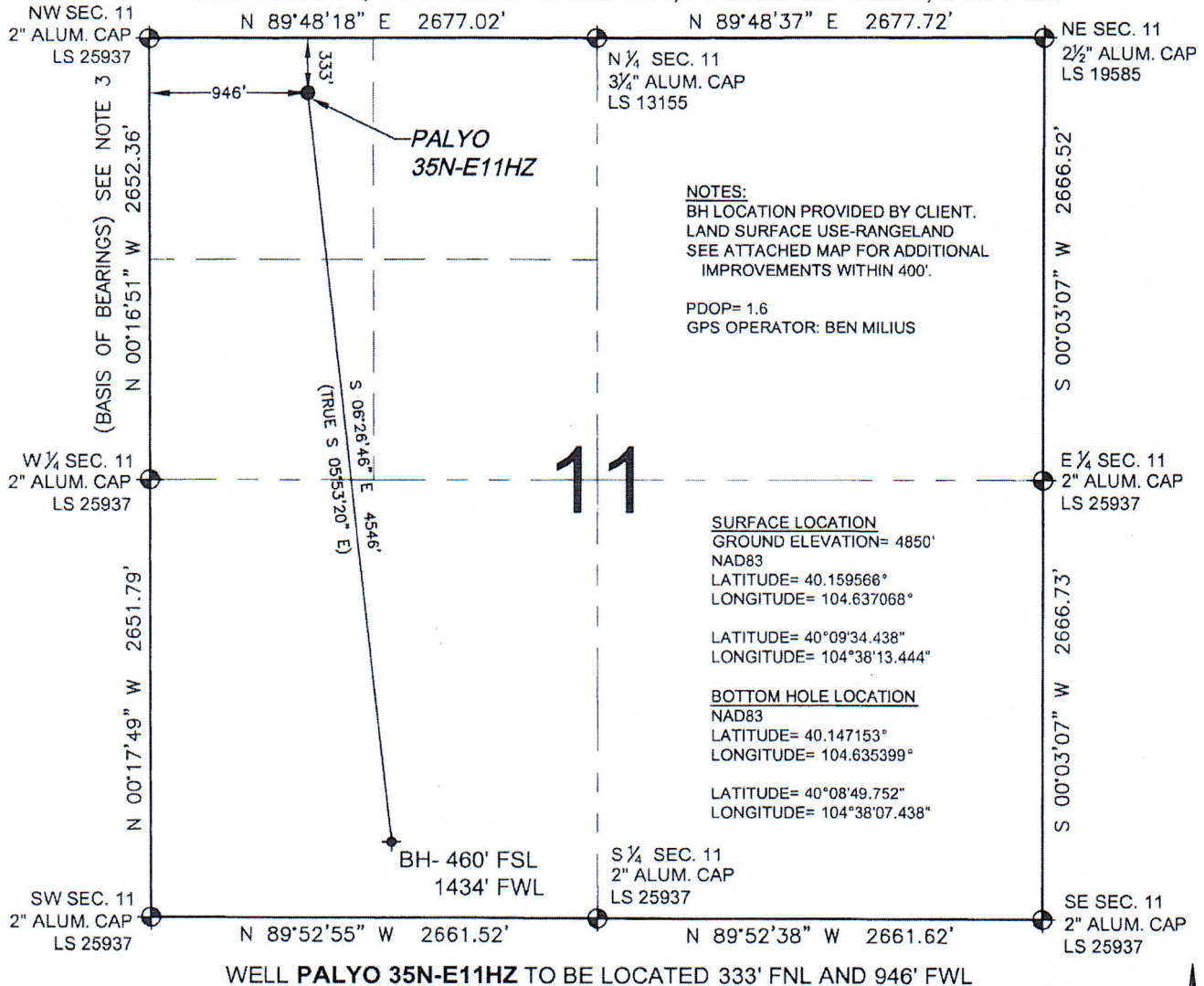

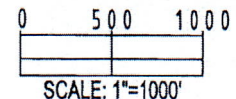
WELL LOCATION CERTIFICATE: PALYO 35N-E11HZ
