Dear Kelly Sheridan:

In accordance with Rule 305.e.(1).B of the Rules and Regulations of the Colorado Oil and Gas Conservation Commission ("COGCC"), this letter serves as a 30-day notice by Matrix Oil Corporation of its intention to commence operations for the drilling of a well on the above-referenced location. Matrix' operations are estimated to begin within the next 180+ days from the date of this letter, pending receipt of required permits and drilling rig availability. COGCC regulations provide that the surface owner may waive the 30-day notice requirement.

In accordance with Rule 306.a of the Rules and Regulations of the COGCC requires written notice from the surface owner to request or waive a consultation meeting with Matrix Oil Corporation concerning the location of the above-referenced well and all associated equipment, or designate a representative for surface consultation.

Enclosed is a waiver and request for consultation form. Please read and fill out the form stating your decision on the thirty (30) day notice and consultation meeting as required by Rule 305 and Rule 306. Return the fully executed form in the envelope provided within the next 10 days.


Also enclosed is a copy of the COGCC's brochure describing surface owner rights and responsibilities.
