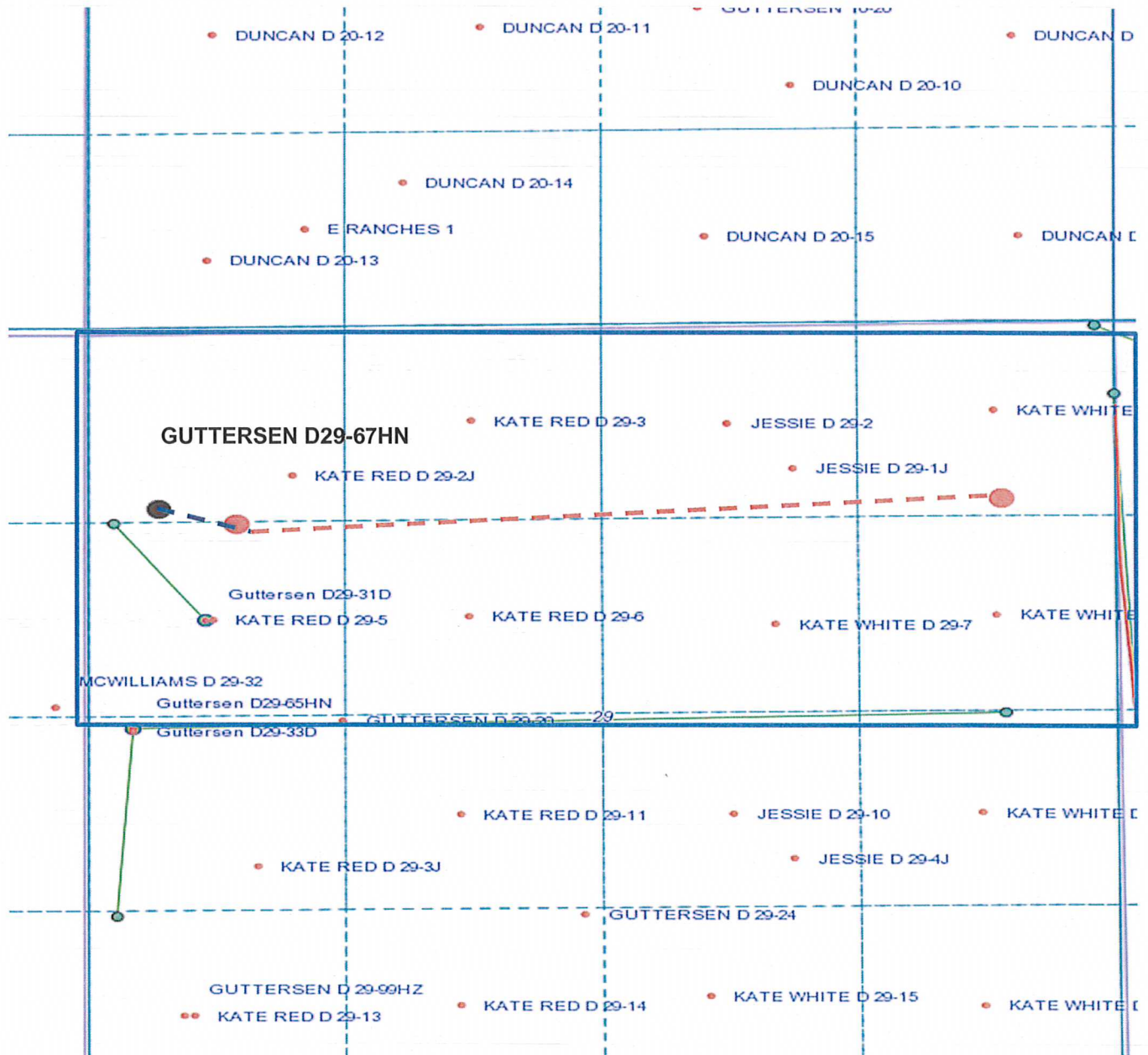

Bottom Hole Location

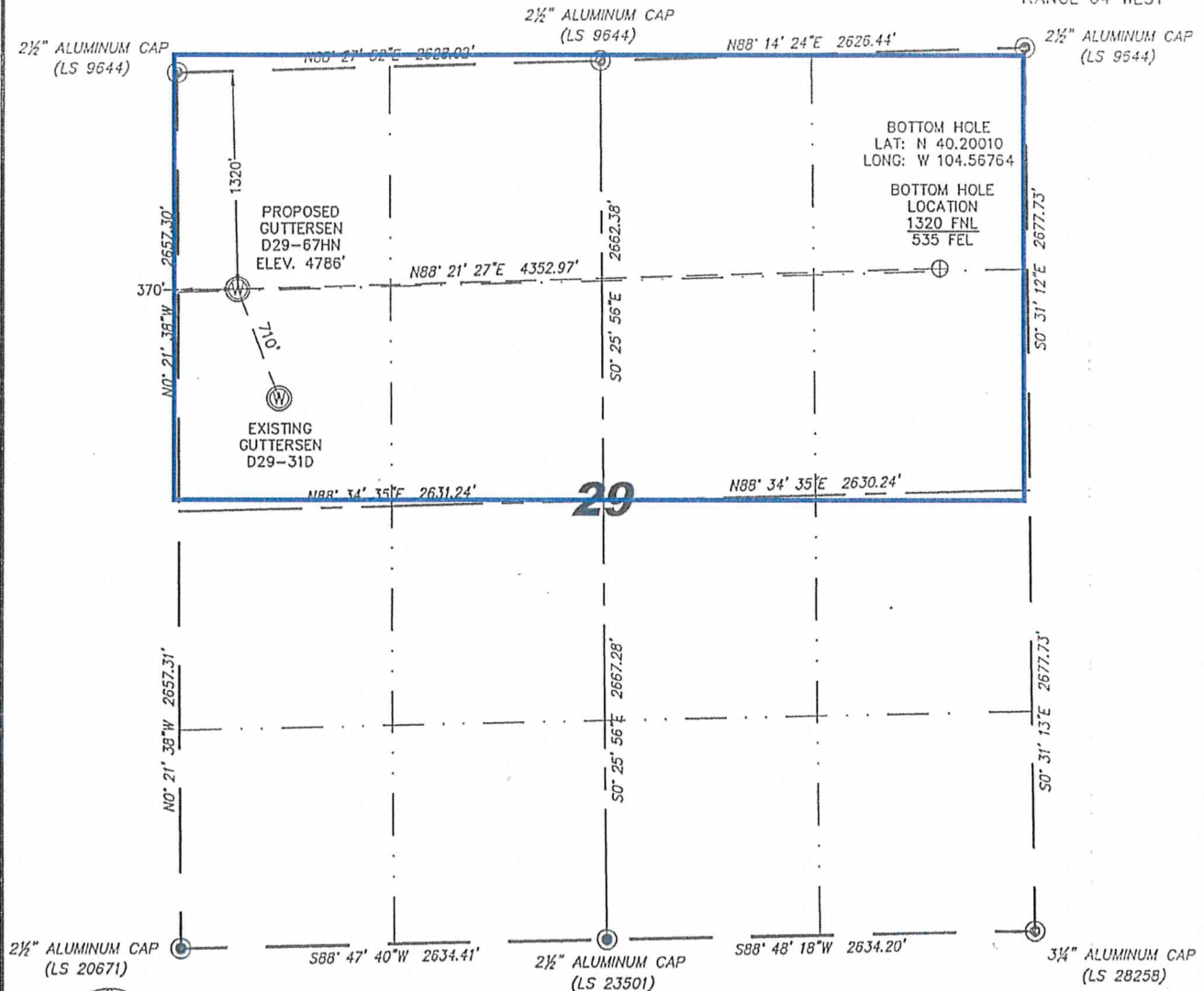
