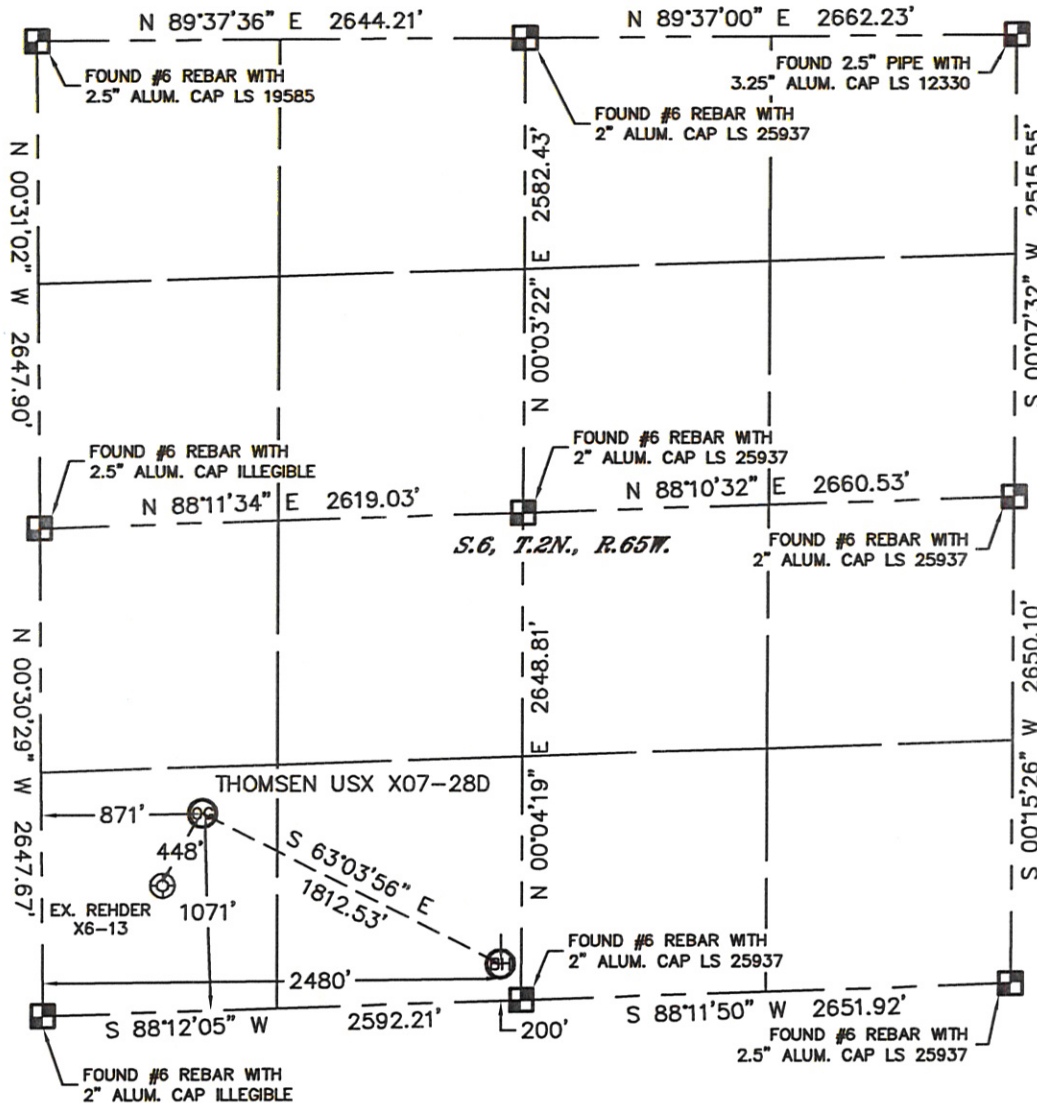


# WELL LOCATION CERTIFICATE

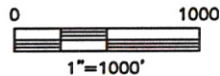
THIS MAP DOES NOT REPRESENT A BOUNDARY SURVEY

In accordance with a request from Ryan Hawkins with Noble Energy Inc. Lat40°, Inc. has determined the surface location of the THOMSEN USX X07-28D to be 1071' from the SOUTH line and 871' from the WEST line and the bottom hole to be 200' from the SOUTH line and 2480' from the WEST line as measured at right angles from the section lines of Section 6, Township 2 North, Range 65 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 12/9/11, for and on behalf of Noble Energy Inc. That this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future improvement lines.

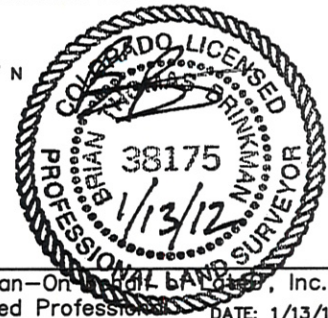

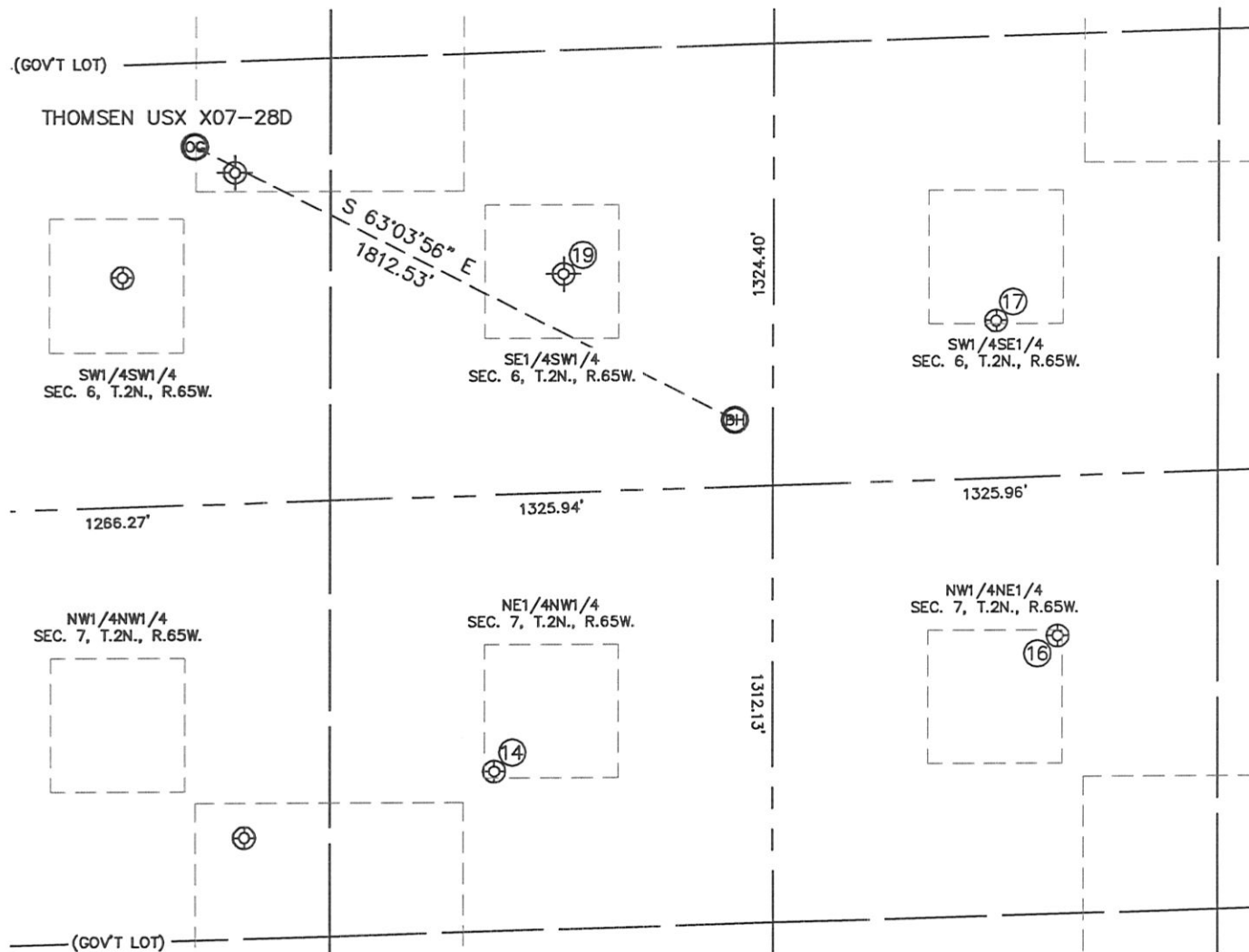
