5. DESCRIBE PROPOSED OR COMPLETED OPERATIONS

Encana Oil & Gas (USA) Inc recieved verbal approval via email on 4/10/2012 to run intermediate casing on the above referenced well. We were unable to drill ahead with a 12.4ppg MW due to well control concerns and also unable to drill ahead with the 12.6 ppg MW due to loss circulation concerns. We have decided to run an intermediate string of 7" 23# casing to ~ 4,450'.
