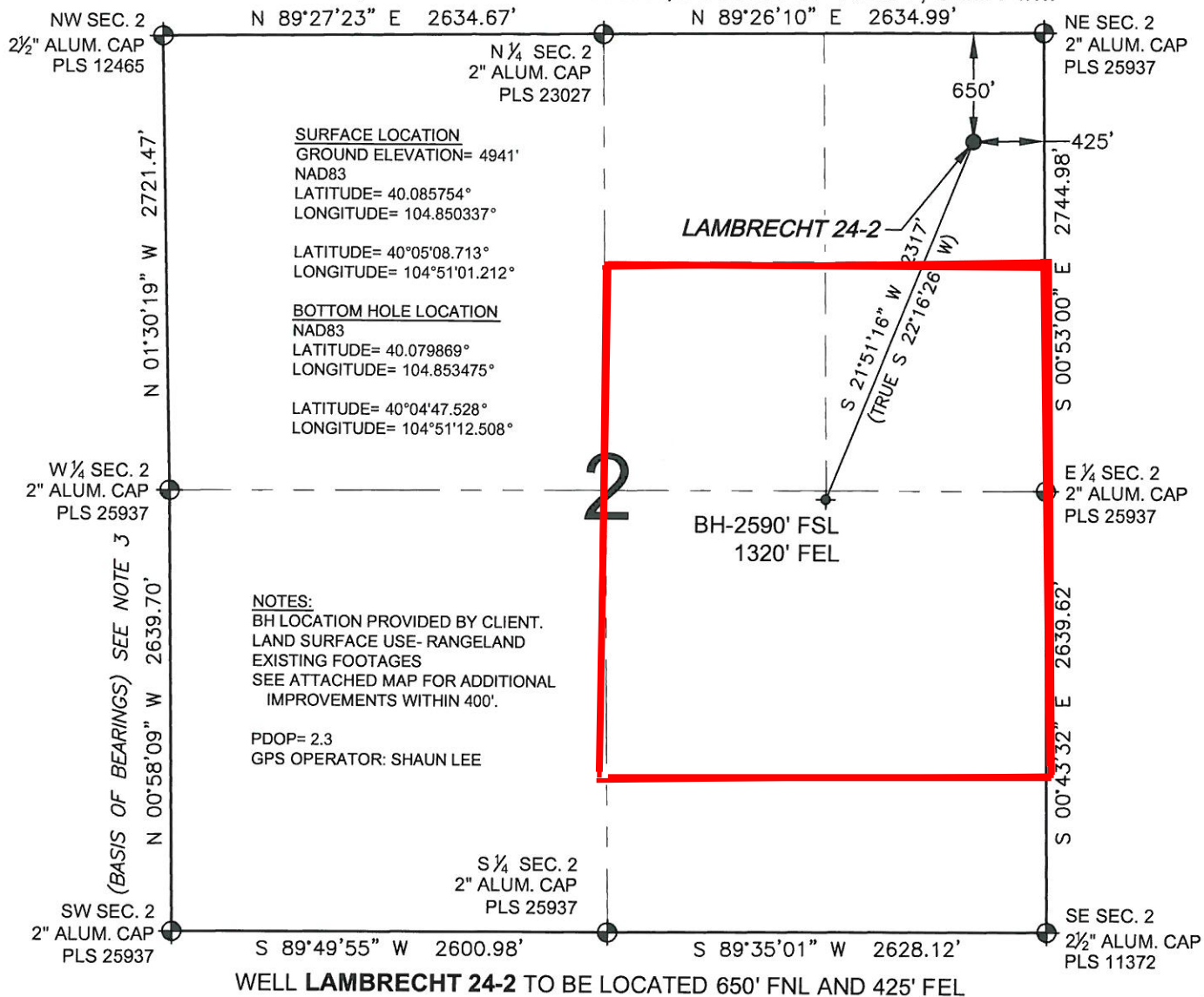

## SPACING UNIT PLAN

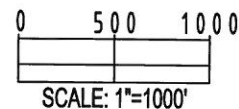
## WELL LOCATION CERTIFICATE: LAMBRECHT 24-2
