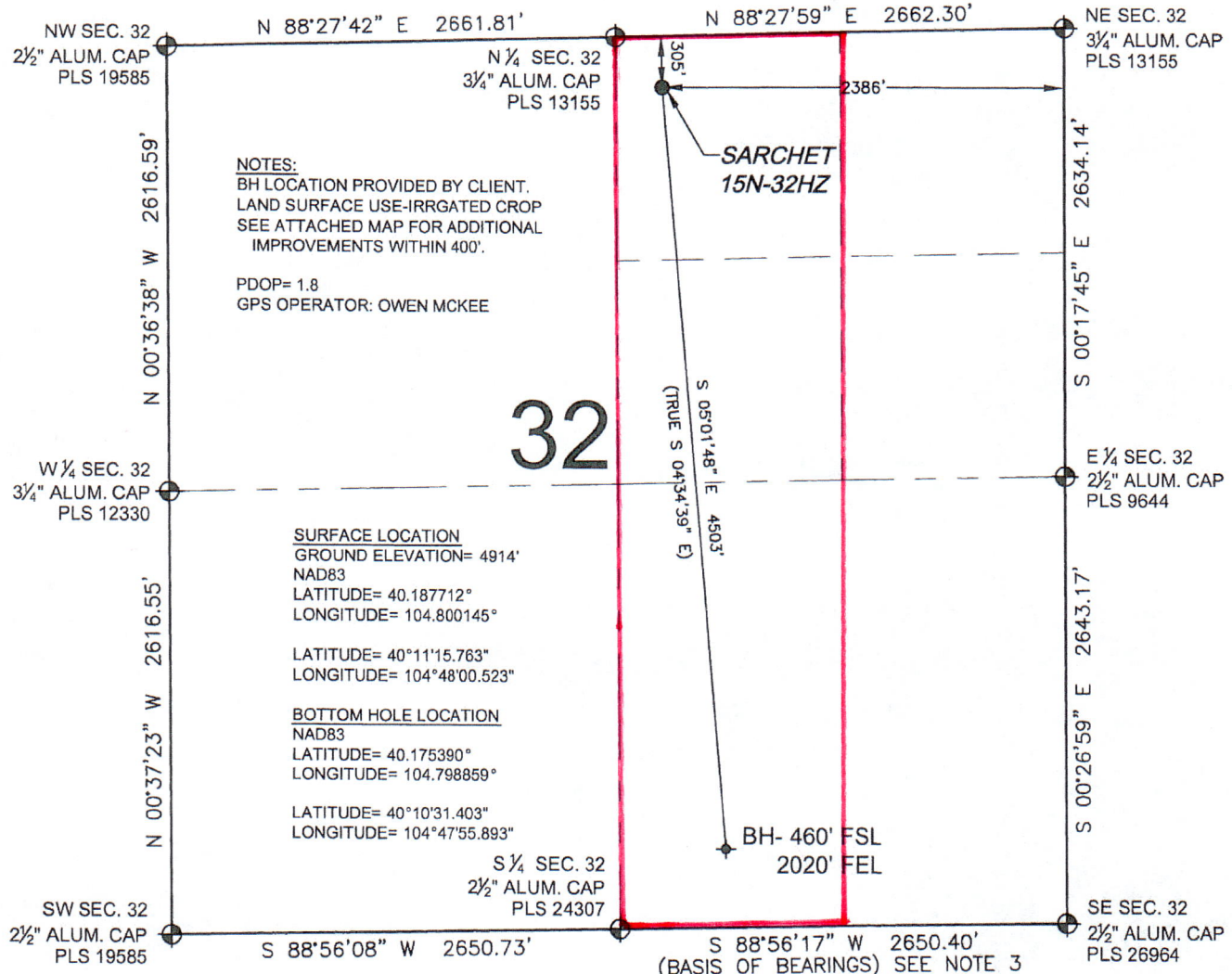

WELL LOCATION CERTIFICATE: SARCHET 15N-32HZ

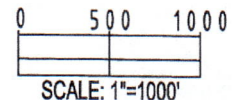
