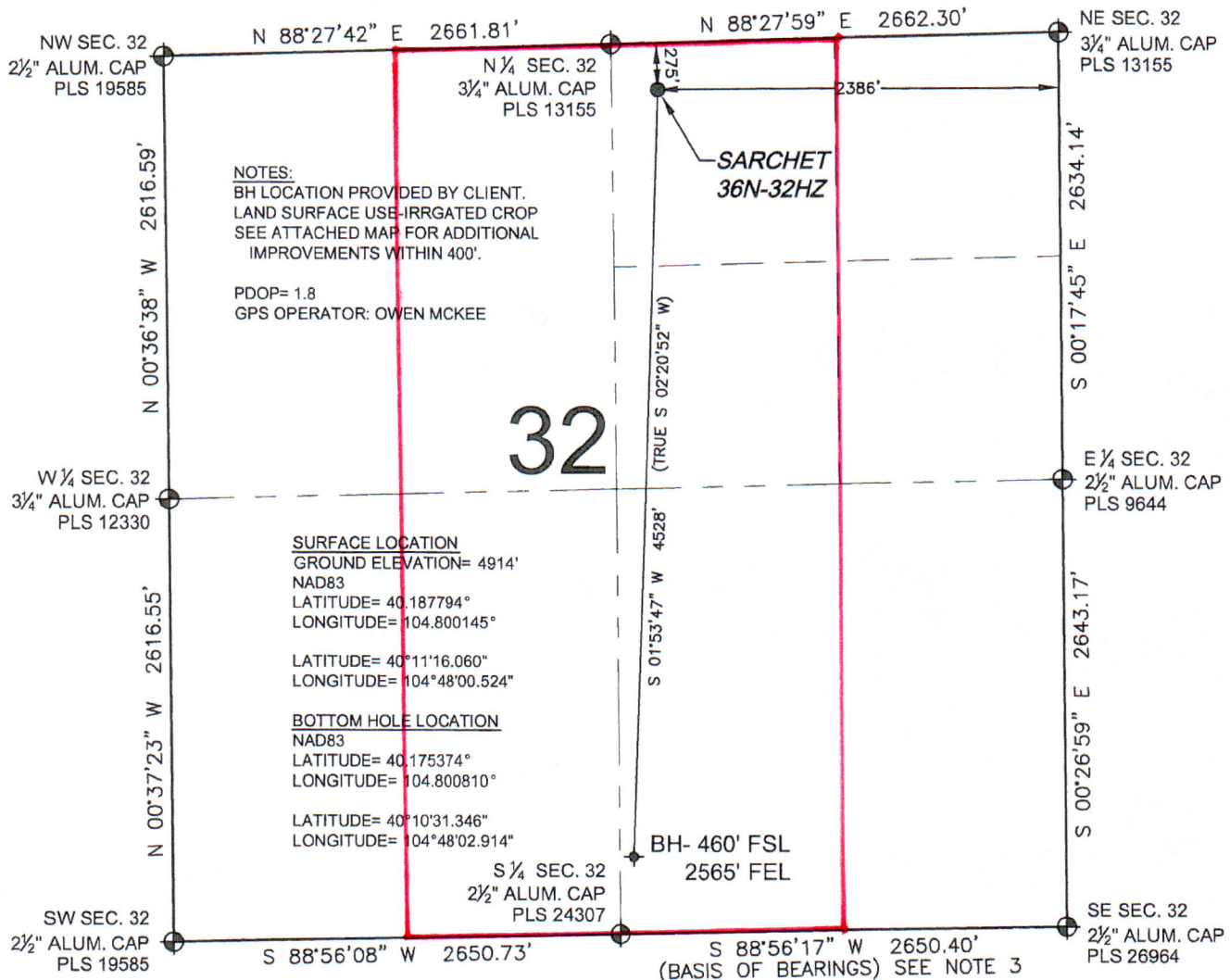

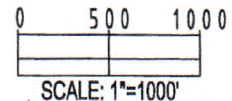
WELL LOCATION CERTIFICATE: SARCHET 36N-32HZ

● = PROPOSED WELL ◆ = EXISTING WELL

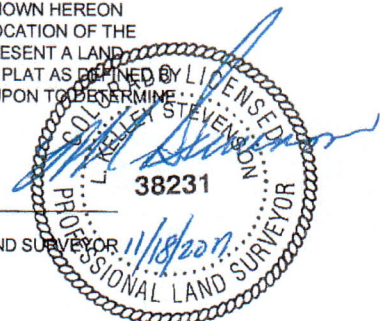
