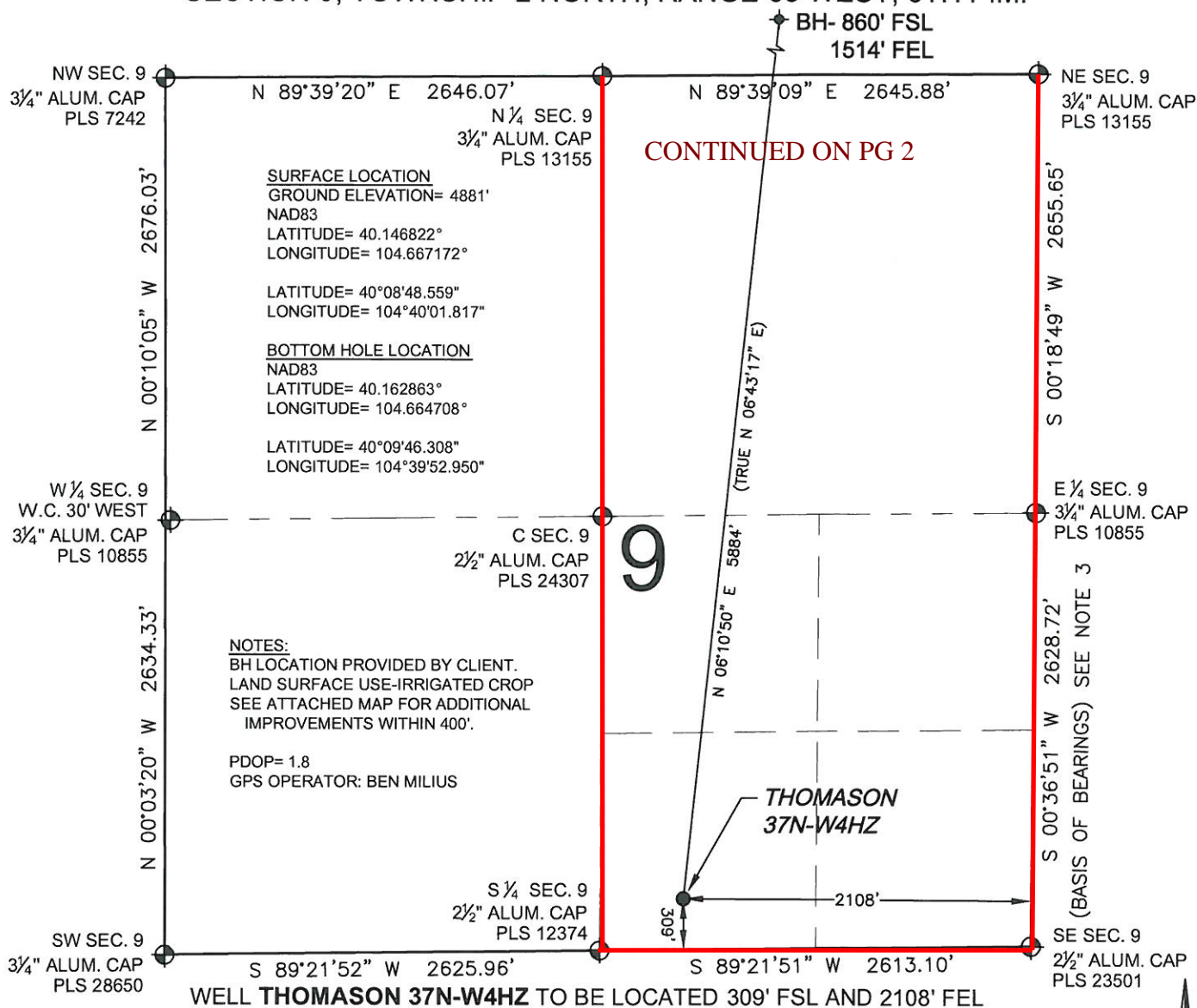

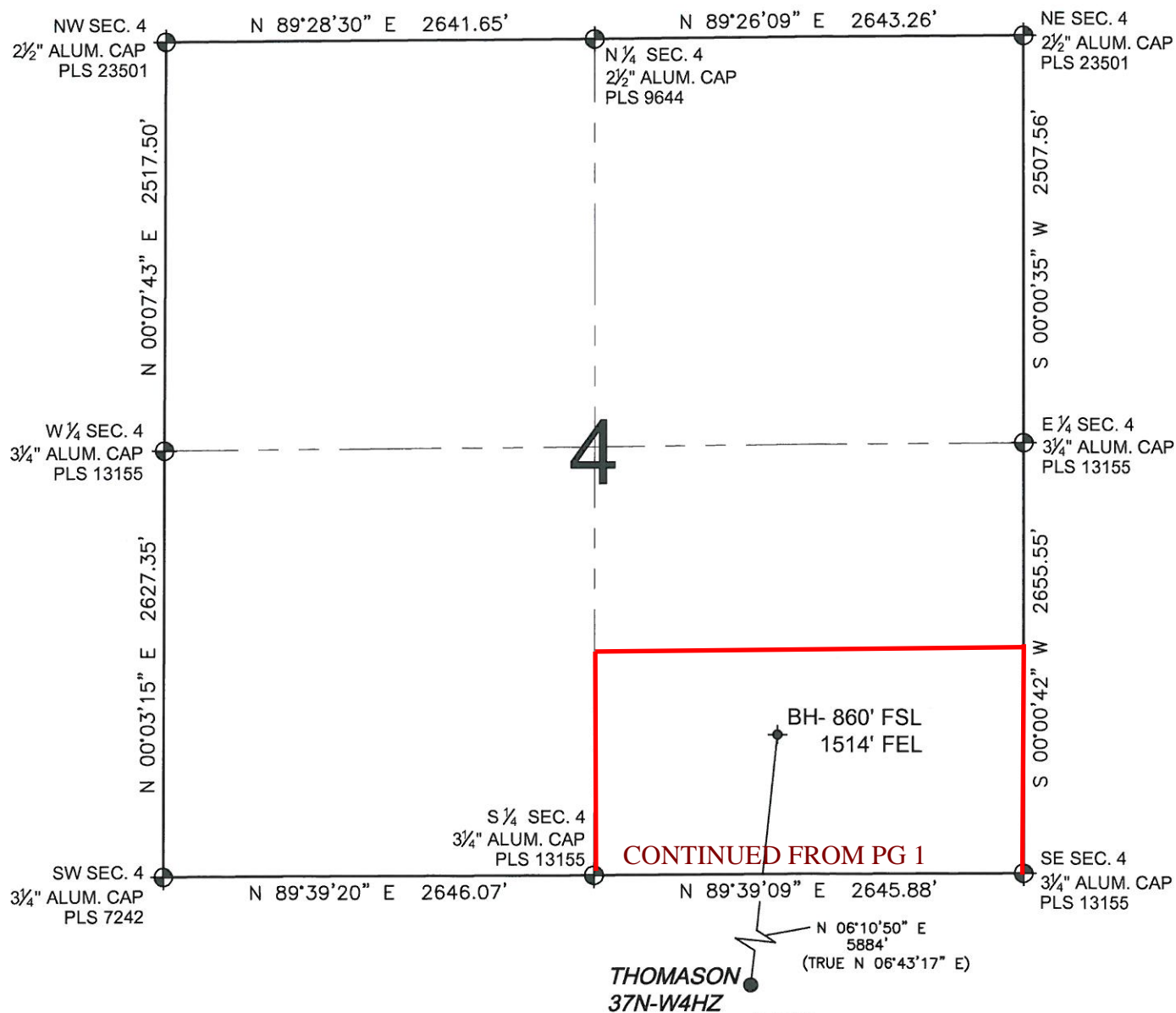

## WELL LOCATION CERTIFICATE: THOMASON 37N-W4HZ



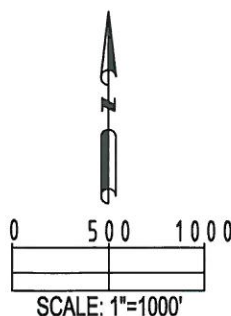
