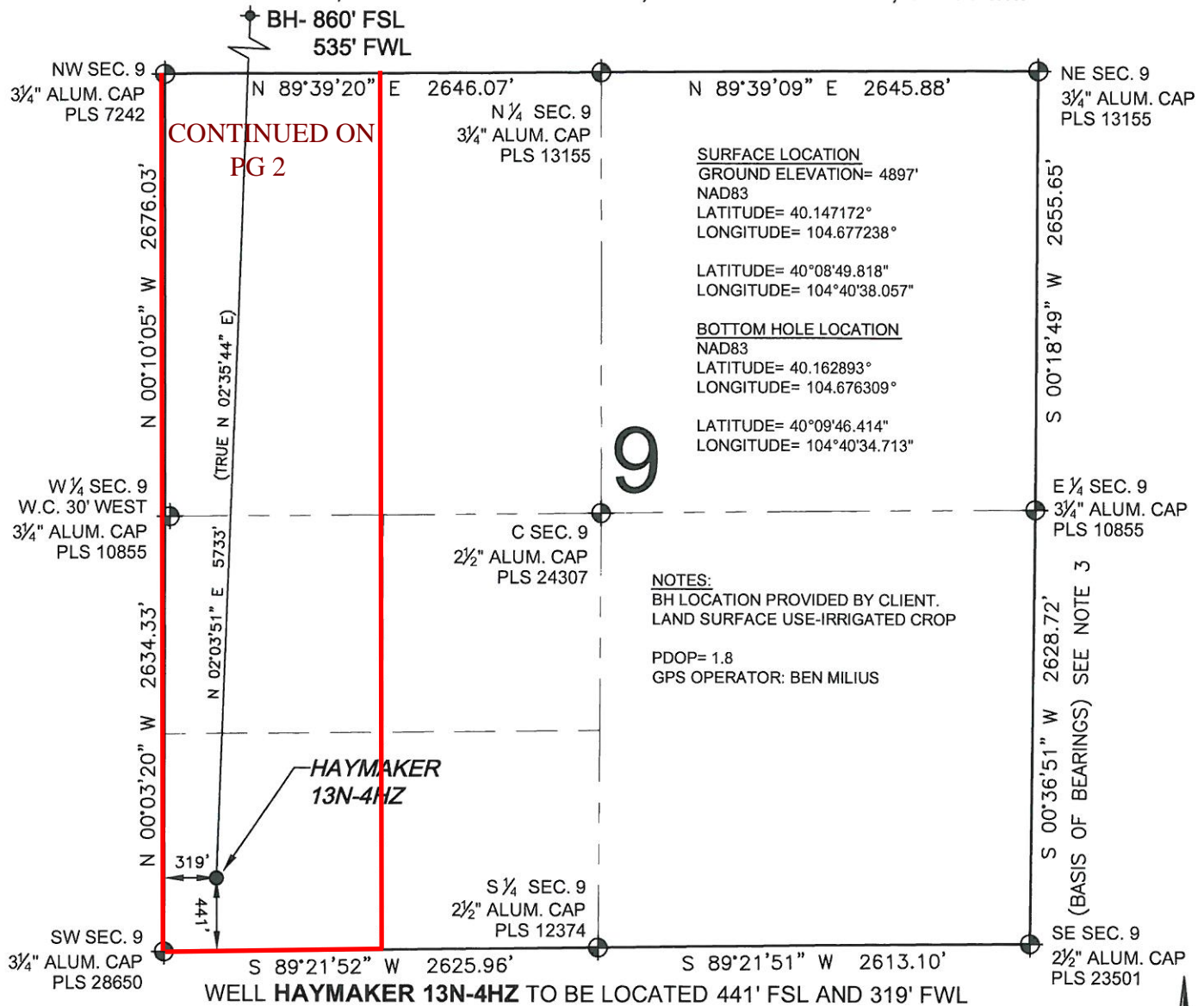

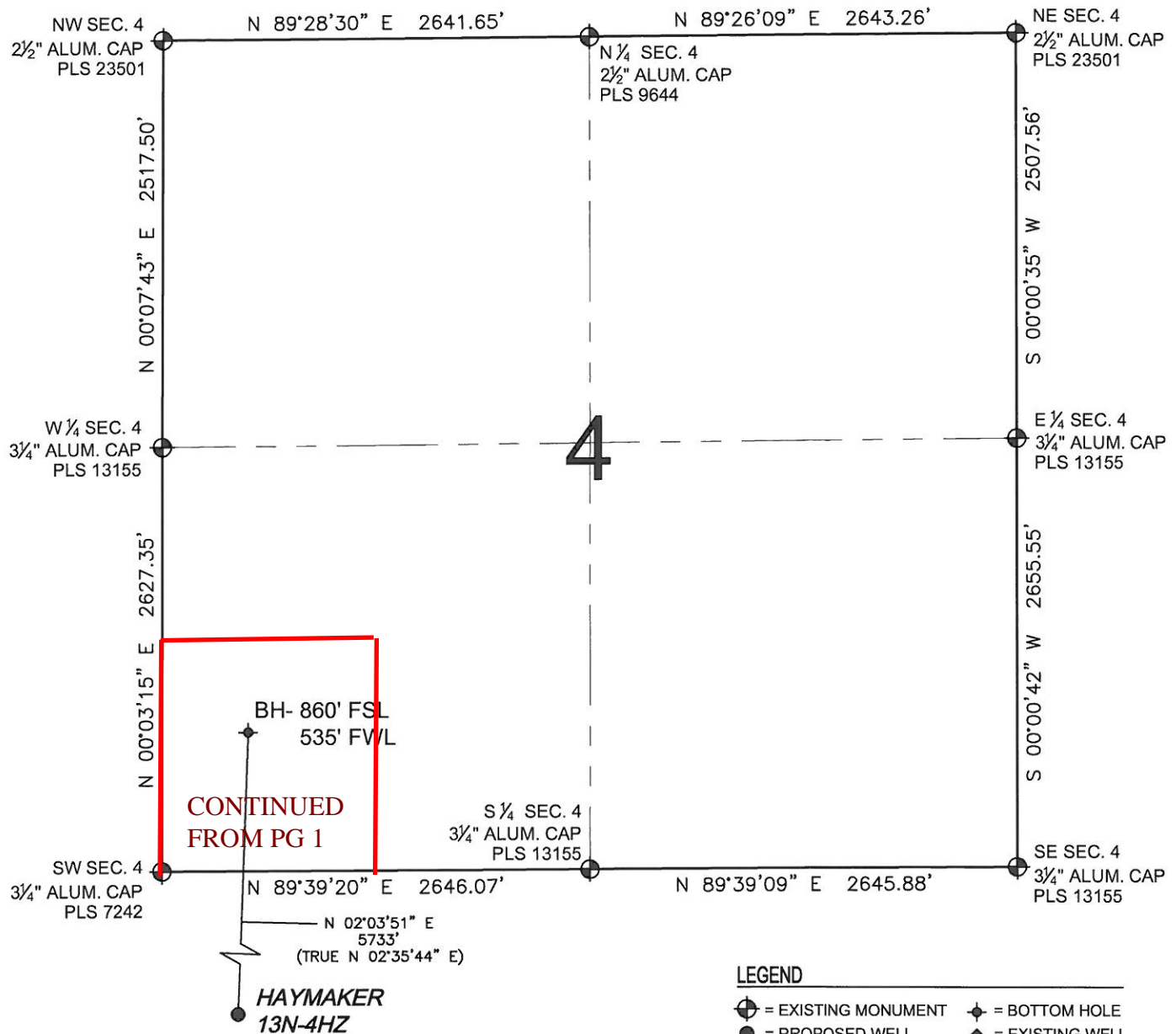

## WELL LOCATION CERTIFICATE: HAYMAKER 13N-4HZ



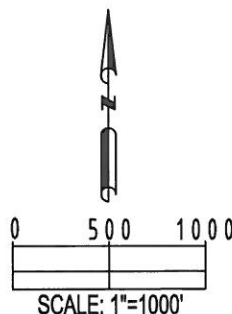
