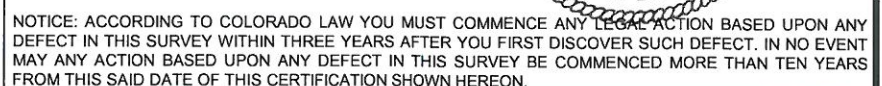

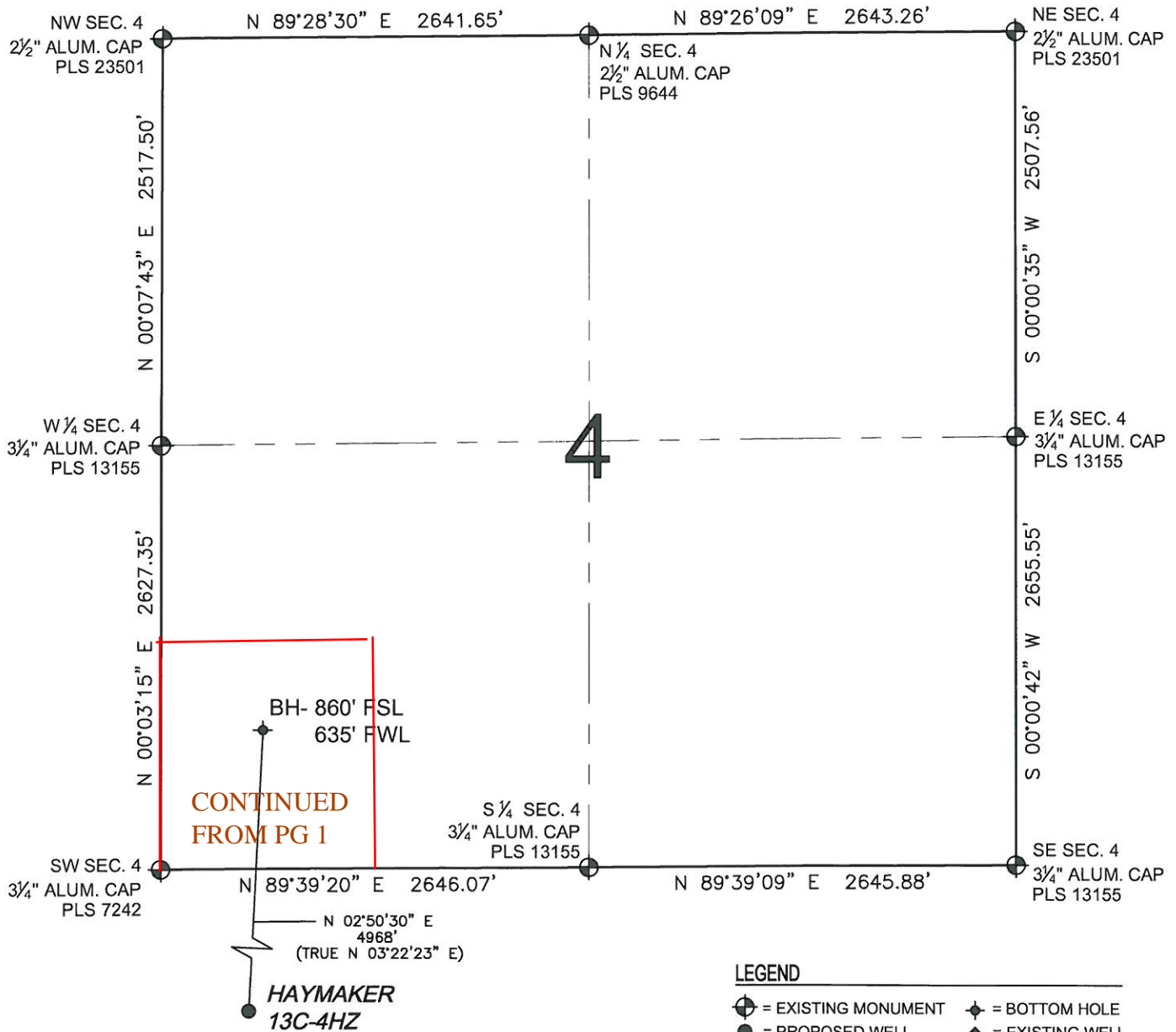

WELL LOCATION CERTIFICATE: HAYMAKER 13C-4HZ



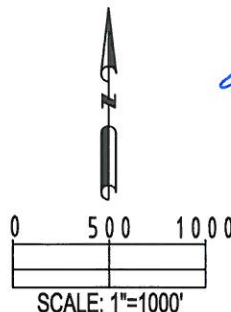
