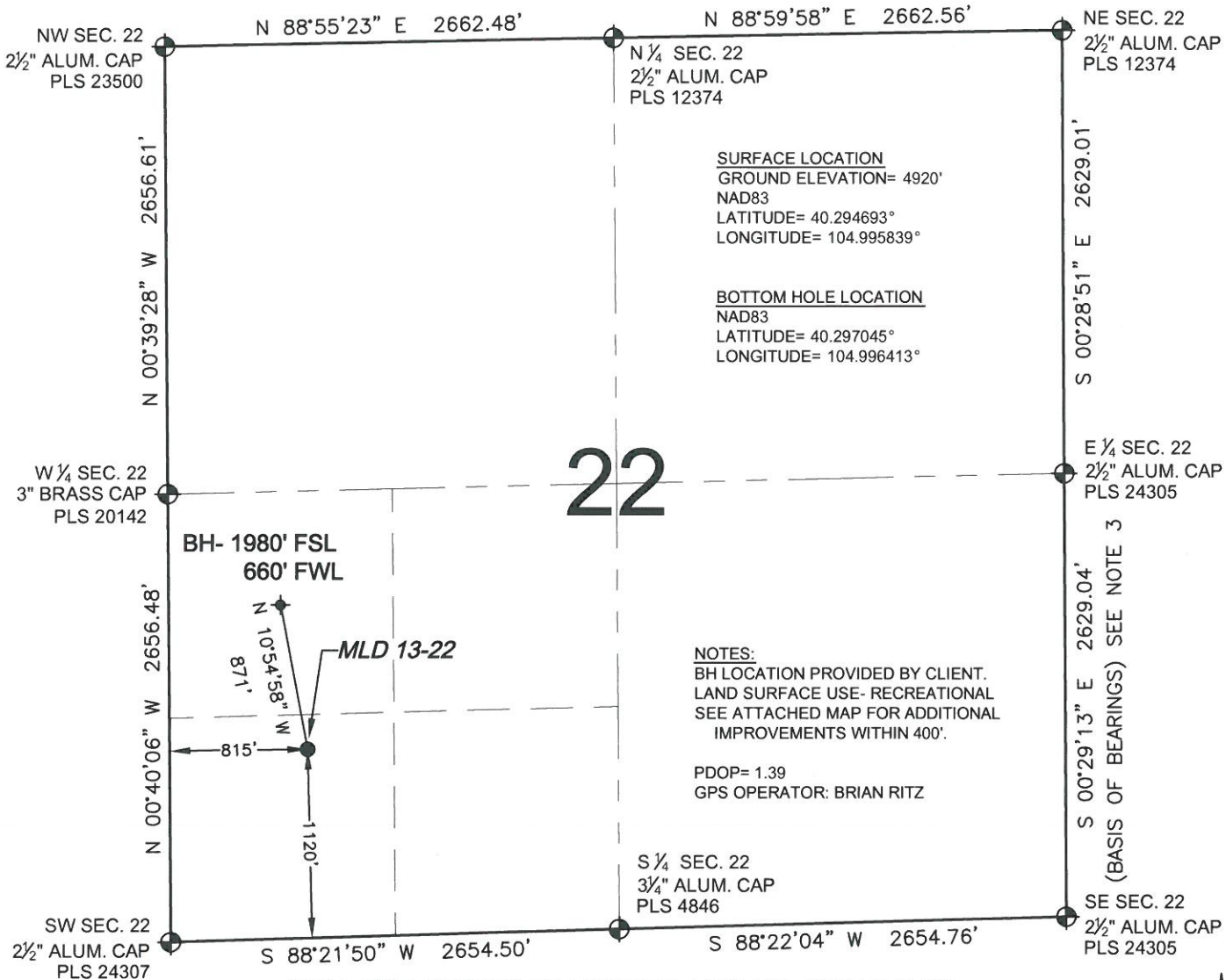


WELL LOCATION CERTIFICATE: MLD 13-22

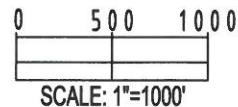
SECTION 22, TOWNSHIP 4 NORTH, RANGE 68 WEST, 6TH P.M.
