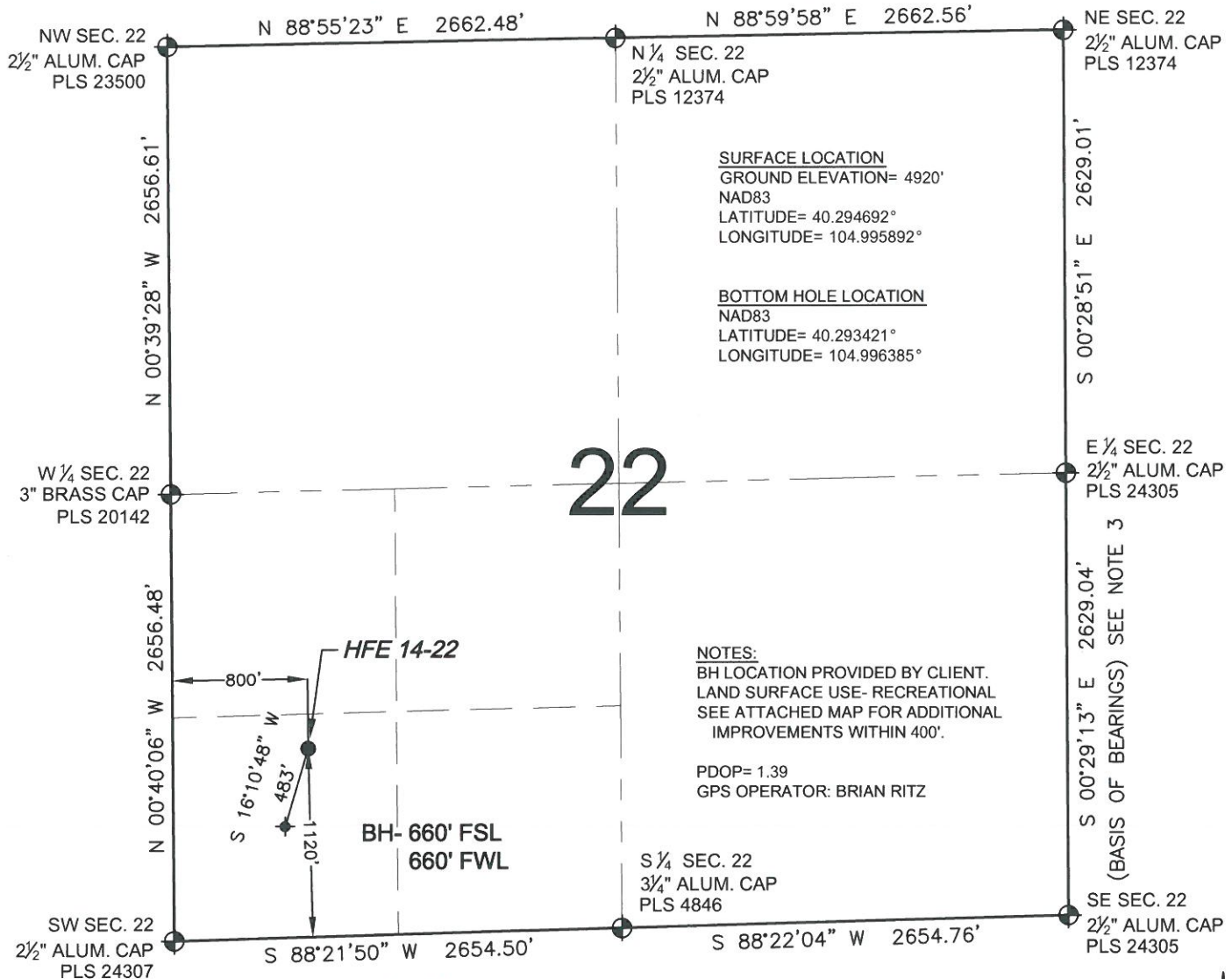


WELL LOCATION CERTIFICATE: HFE 14-22

LEGEND

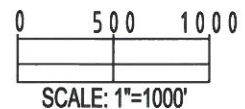
- = EXISTING MONUMENT ♦ = BOTTOM HOLE BH = BOTTOM HOLE
