Kallasandra,

The COGCC is reviewing the Form 2A (#400271228) for the Winn Exploration Slanovich 34-27 location, located in the NWSE Sec 27 T19S R70W Fremont County, Colorado. The COGCC requests approval of the following changes and recognition of the conditions of approval prior to passing the Oil and Gas Location Assessment (OGLA).

Construction

Method of mud disposal – Mud may not be spread on rangeland. Please provide an alternative method of disposing of the mud. **I am working on this.**

Sensitive Area Determination

Due to the close proximity of an ephemeral stream to the proposed location and the presence of shallow groundwater the area should be considered a sensitive area. The Sensitive Area tab will be changed to yes. **That is fine.**

Depth to groundwater

The depth to groundwater should be changed to 20 feet to reflect the water level at water well permit #47624. **That is fine.**

Conditions of Approval

The following Condition of approval shall apply to the Slanovich 34-27 location: **Noted**

- Operator must implement site-specific best management practices in accordance with good engineering practices, including, but not limited to, construction of a berm or diversion dike, site grading, or other comparable measures, sufficient to protect intermittent stream located 286 feet South-East of the staked oil and gas location from a release of drilling, completion, produced fluids, and chemical products.
- Location is in a sensitive area because of shallow groundwater; therefore, either a lined drilling pit or closed loop system is required.
