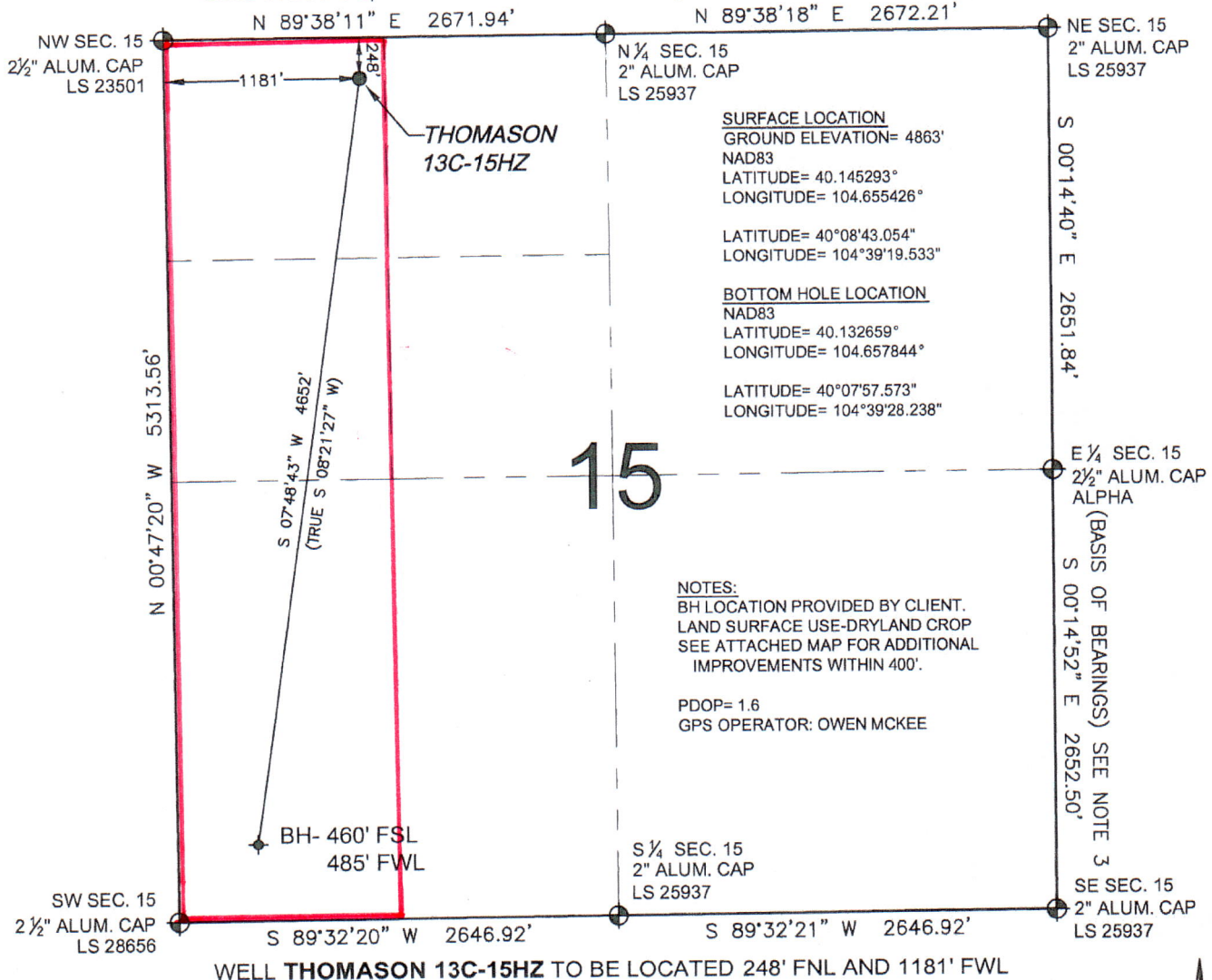

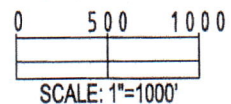
WELL LOCATION CERTIFICATE: THOMASON 13C-15HZ
