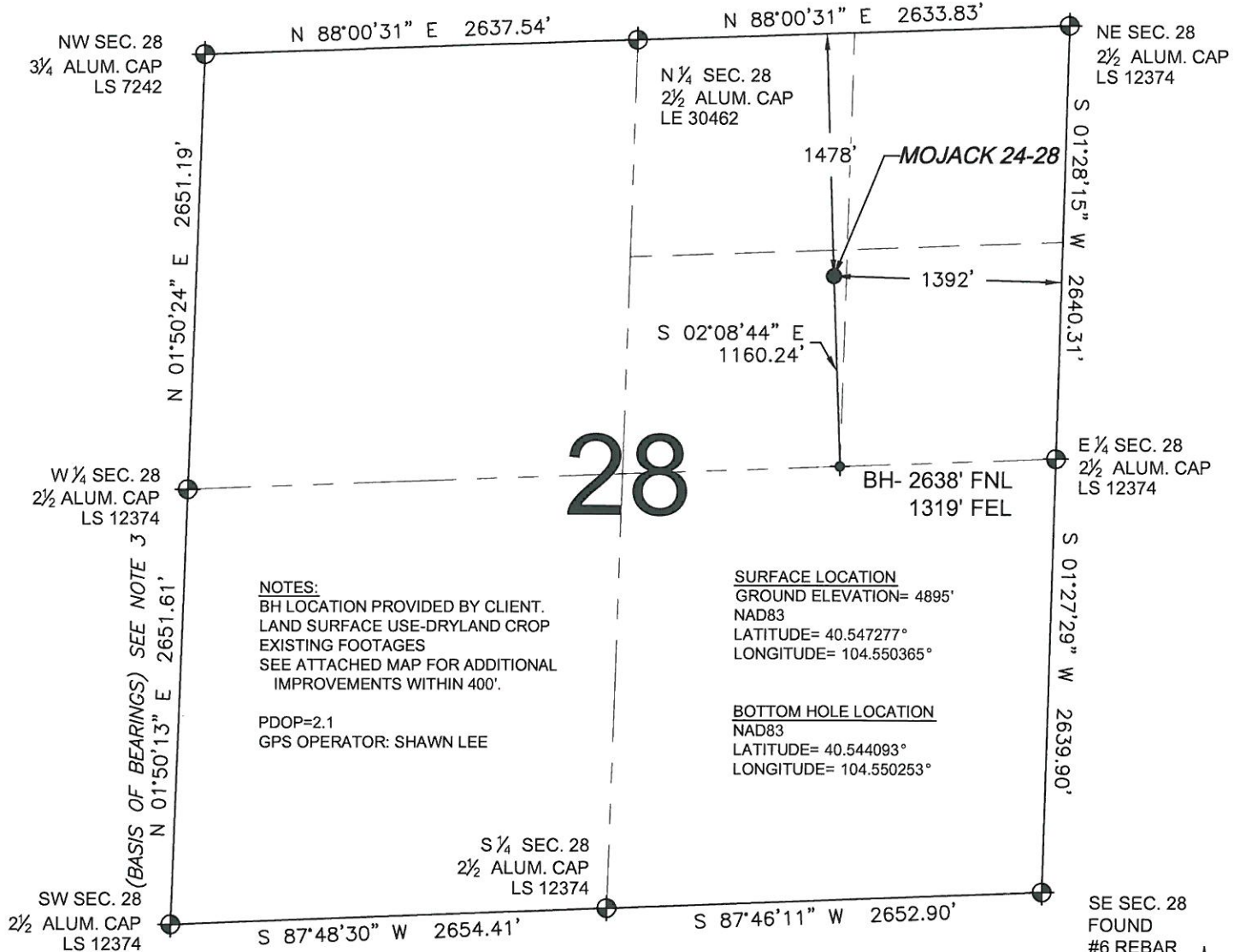


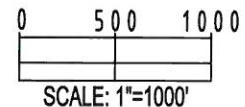
# WELL LOCATION CERTIFICATE: MOJACK 24-28
