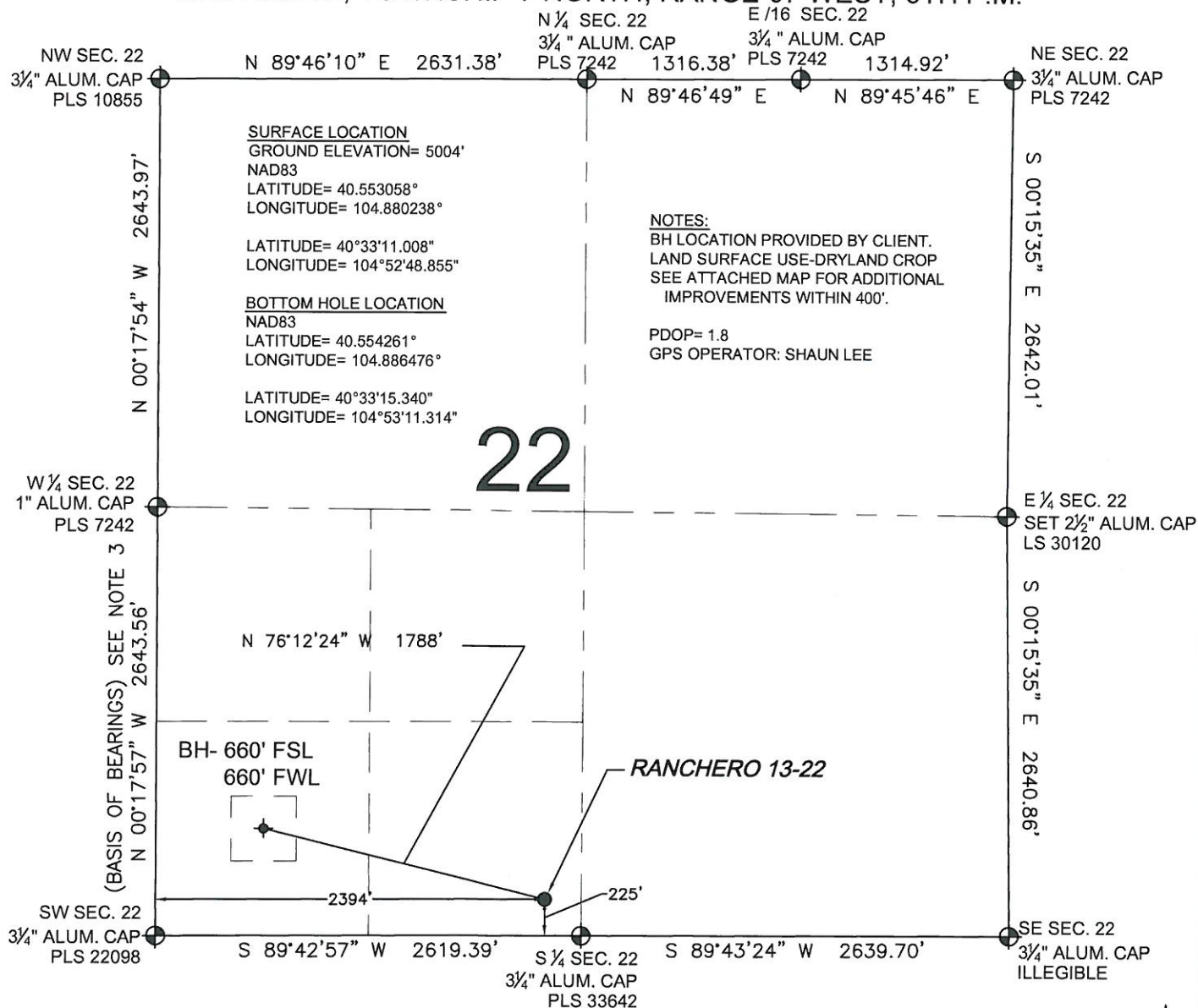


WELL LOCATION CERTIFICATE: RANCHERO 13-22

● = PROPOSED WELL ◆ = EXISTING WELL

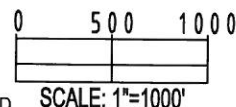
