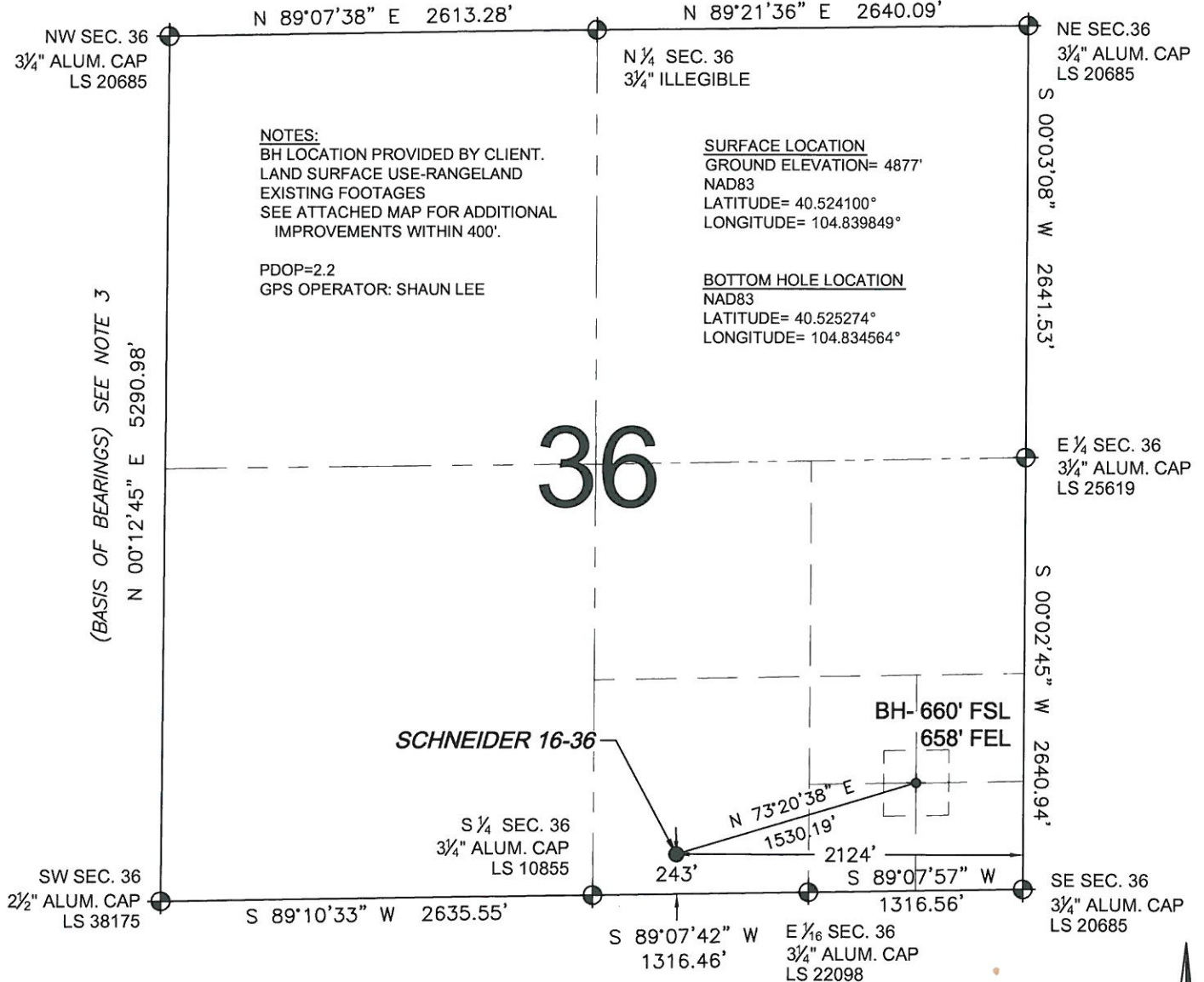
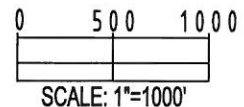


WELL LOCATION CERTIFICATE: SCHNEIDER 16-36
