



Lat40°, Inc. has determined the surface location of the BOOTH STATE C36-69HN to be 250' from the NORTH line and 253' from the EAST line and the bottom hole to be 75' from the NORTH line and 535' from the WEST line as measured at right angles from the section lines of Section 36, Township 4 North, Range 64 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 11/3/11, for and on behalf of Noble Energy Inc. That this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future Improvement lines.




