<p>Inspected the Gutttersen State D 16-27 for alleged piles of cuttings directly south of the wellsite. No cuttings were found. I called Mr. Art Gutttersen and told him that I was inspecting the well sites in section 16 -3N-64W for alleged drill cuttings. He said that he had also received a letter from the Sierra Club and was highly offended by the letter. He said I could check all I wanted and that he was willing to open the property to anyone to check for cuttings. He said they would find none. He told me that he had over a thousand head of cattle and what the satellite views represented were feeding stations, nothing more. I also called Mr. Ryan Litfin from Noble and asked him if he knew of any drill cuttings being placed on the Gutttersen property?
