*Thank you for your diligence in discussing specific BMPs for these two wells in Fremont County, CO.*

*CPW staff has reviewed these locations and recommends the following BMPs:*

- 1. The wells are located in mapped elk winter range and our recommendation for these facilities is avoid new construction between December 1 and April 15th.*
- 2. COGCC Rule 1204 (a) (1) relating to operator installation and utilization of black bear dumpsters and receptacles for is certainly applicable in this area and we encourage operators to comply with this rule to avoid human-bear conflicts at their drill sites.*
