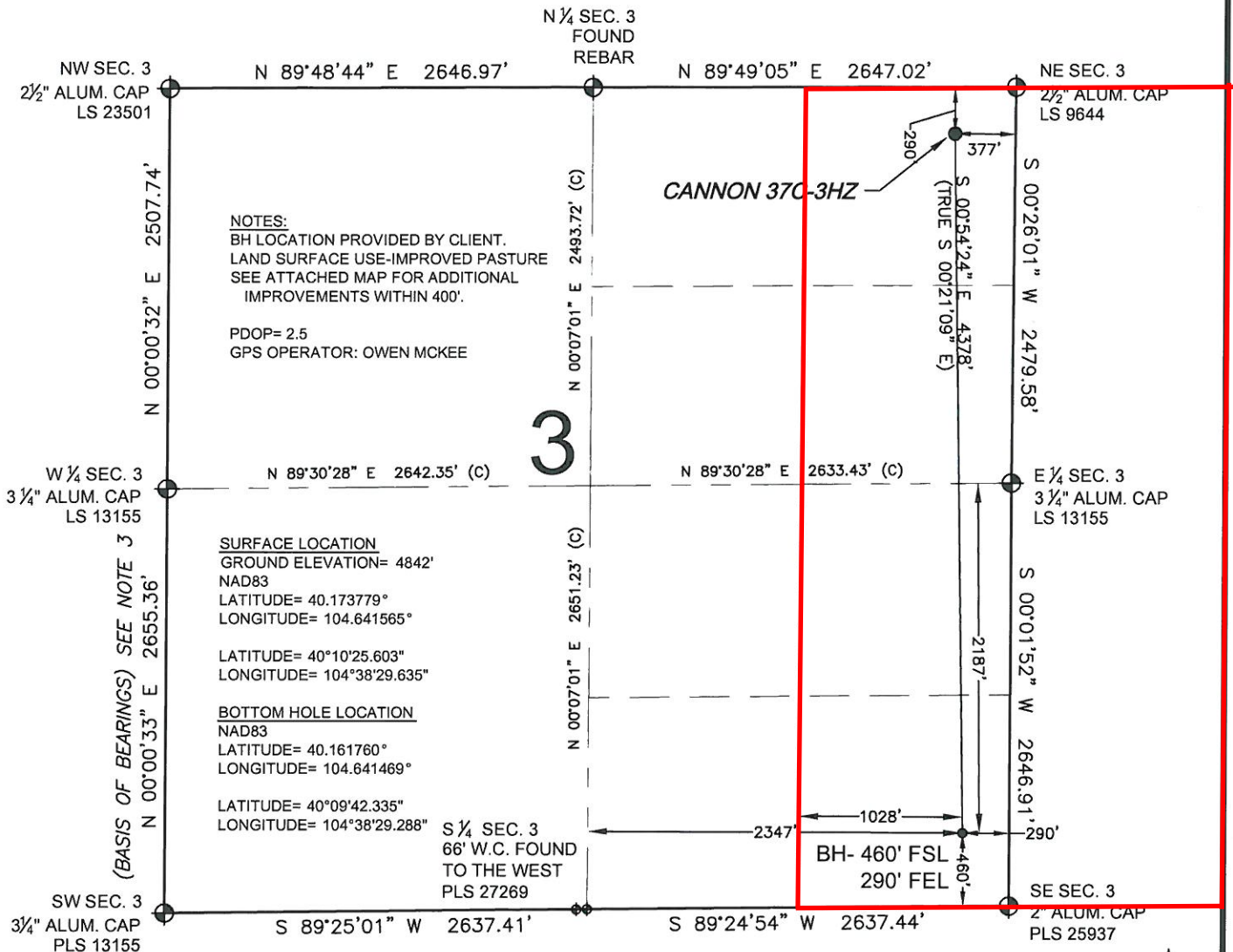

PROPOSED SPACING UNIT

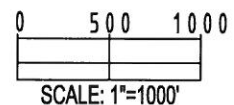
WELL LOCATION CERTIFICATE: CANNON 37C-3HZ
