This well inspected for noise complaint. calibrated meter-used "A" scale slow . All readings were taken 350 ft from noise source. South drilling 43db--bucket emptied 67 db for 15 second duration. East drilling 45 db--bucket emptied for 60 second duration 69 db . North drilling 44 db bucket emptied for 36 second duration 67 db. West drilling 45 db bucket emptied for 20 second duration 67db. It appears that the average duration is about 30 seconds for emptying. and the noise is listed at the peak for the duration. The noise readings are acceptable under the industrial rating The test was conducted from 6:30P.M. to 8:00PM.	precupj	05/31/2012
