33. Comments No conductor casing will be used/The surface location of this well is an exception to Rule 318A.a and to Rule 318A.c. This well is not within the GWA surface location window and does not meet the twinning requirement due to the number of wells planned for this area and at the request of the surface owner. An exception location request letter and signed waivers are attached to the Form 2 and Form 2A/Kerr-McGee Oil & Gas Onshore LP ("KMG") respectfully requests the Director to waive Rule 318A.m for this well. KMG is the operator of the encroached upon well(s)./We are having trouble on the Camp 3N-31HZ well currently being drilled by XTC20. API 05-123-35140. Intermediate casing was set at 7584' MD and cemented with full returns during the cement job. Cement contaminated water was recovered at the surface at the end of the cement job. The lateral was drilled to 10032' into the Sharon Springs. A half day was required to ream to the casing shoe and the prospects of drilling the well to TD and running the production liner to the bottom of the hole are slim. Jim Precup gave verbal approval to continue with the sidetrack operations at 20:30 on May 30, 2012.
