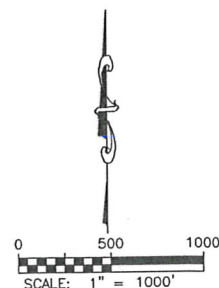
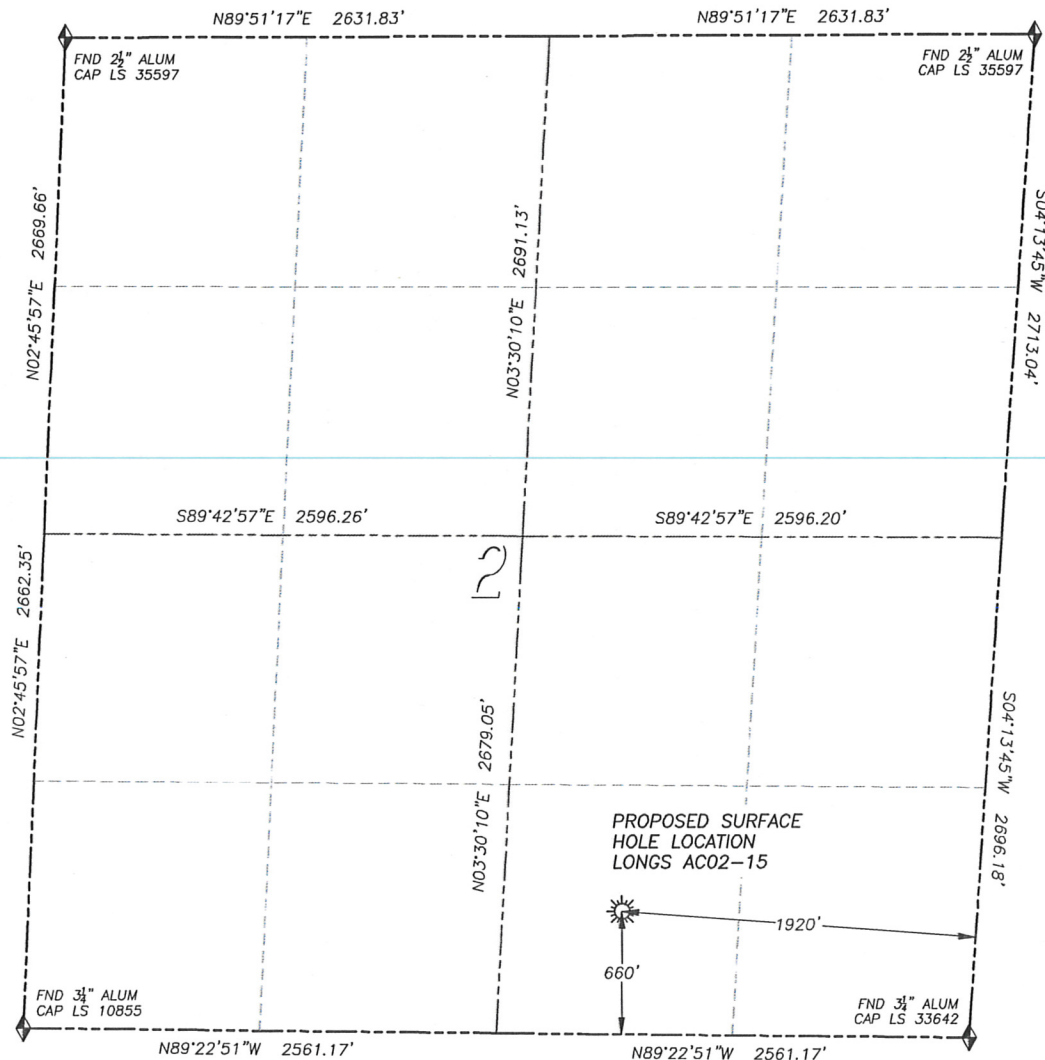

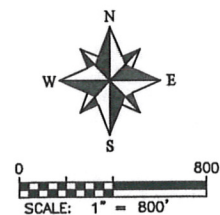
SITE SKETCH LONGS AC02-15
