Hilcorp Energy Company (Hilcorp) hereby requests that the Director grant a waiver to Colorado Oil and Gas Conservation Commission (COGCC) Rule 603.a.(2), for the above referenced well. The surface location, pertaining to the Application for Permit to Drill (APD), does not conform to COGCC Rule 603.a.(2) due to topographical constraints. The preferred location was agreed upon by Hilcorp and Lost Creek Land and Cattle Company at an onsite meeting held December 14, 2011.

The wellsite was originally staked at 140' FSL 690' FWL (SW/4 SW/4) of Sec. 9 T3N R62W on November 30, 2011, by Daley Land Surveying, Inc., surveyor, on a site that was geologically and topographically acceptable. The Bottom Hole Location (BHL) is located at  $\pm 600'$  FSL  $\pm 500'$  FWL (SW/4 SW/4) of Sec. 16 T3N R62W.


Hilcorp requests the Director approve the proposed exception location. The surface owner acknowledges and agrees with the staked surface location of the well.

Hilcorp Energy Company (Hilcorp) hereby requests the Colorado Oil and Gas Conservation Commission (COGCC) Director's approval for a statewide setback location exception waiver for the above referenced well. The well does not conform to the COGCC Rule 603.a.(2), pertaining to the Application for Permit to Drill (APD), for statewide setback requirements due to topographical constraints. The preferred location was agreed upon by Hilcorp and Lost Creek Land & Cattle Company at an onsite meeting held December 14, 2011.

COGCC Rule 603.a.(2) states that "a well shall be a minimum distance of one hundred fifty (150) feet from a surface property line." The above referenced well is located 140' from the South line of the section due to topographical constraints which violates COGCC Rule 603.a.(2).

The wellsite was originally staked at 140' FSL 690' FWL (SW/4 SW/4) of Sec. 9 T3N R62W on November 30, 2011, by Daley Land Surveying, Inc., surveyor, on a site that was geologically and topographically acceptable. The Bottom Hole Location (BHL) is located at ±600' FSL ±500' FWL (SW/4 SW/4) of Sec. 16 T3N R62W.

By approving this matter, we anticipate COGCC granting Hilcorp a state setback location exception waiver to Rule 603.a.(2).


