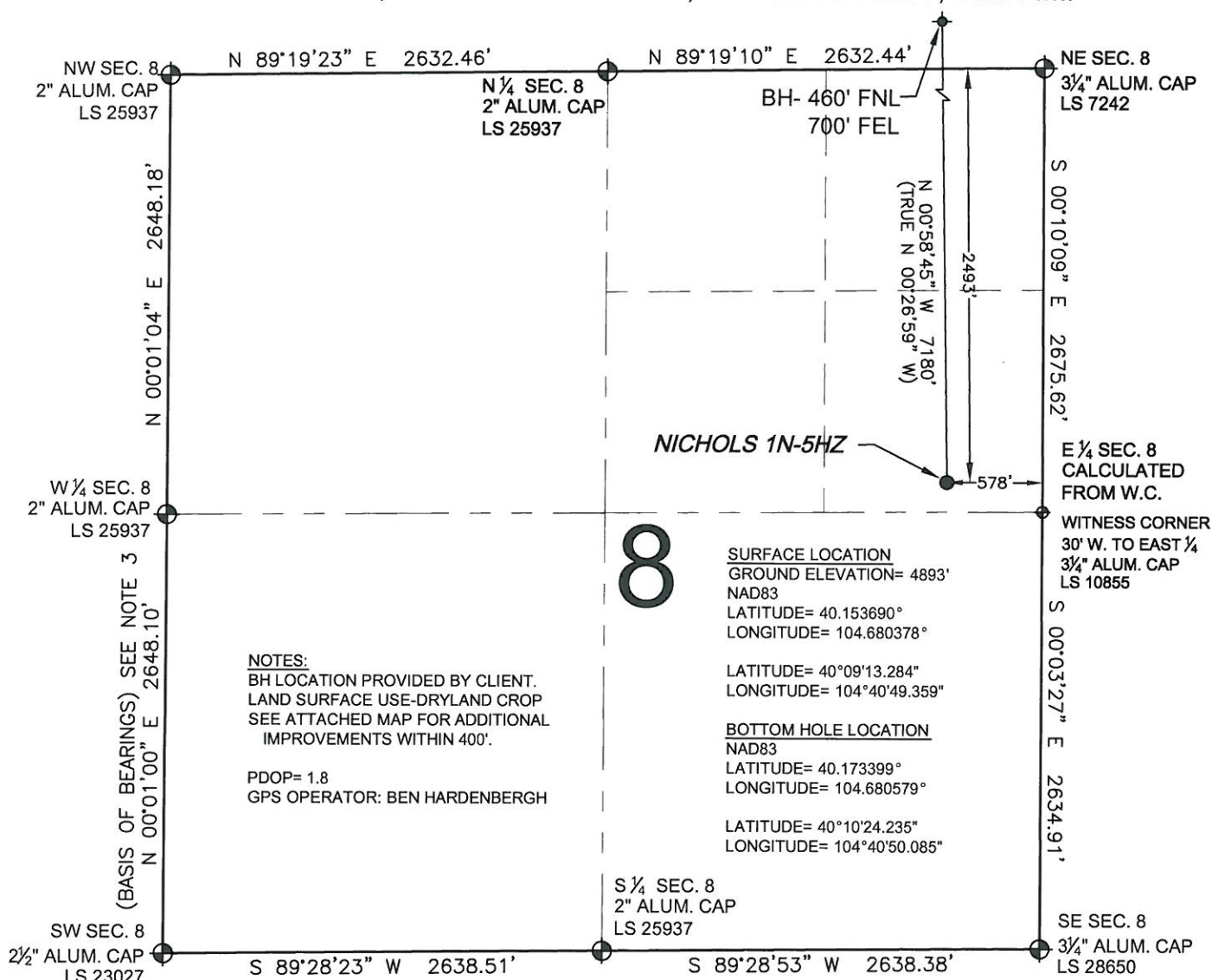


WELL LOCATION CERTIFICATE: NICHOLS 1N-5HZ

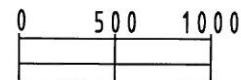
SECTION 8, TOWNSHIP 2 NORTH, RANGE 65 WEST, 6TH P.M.

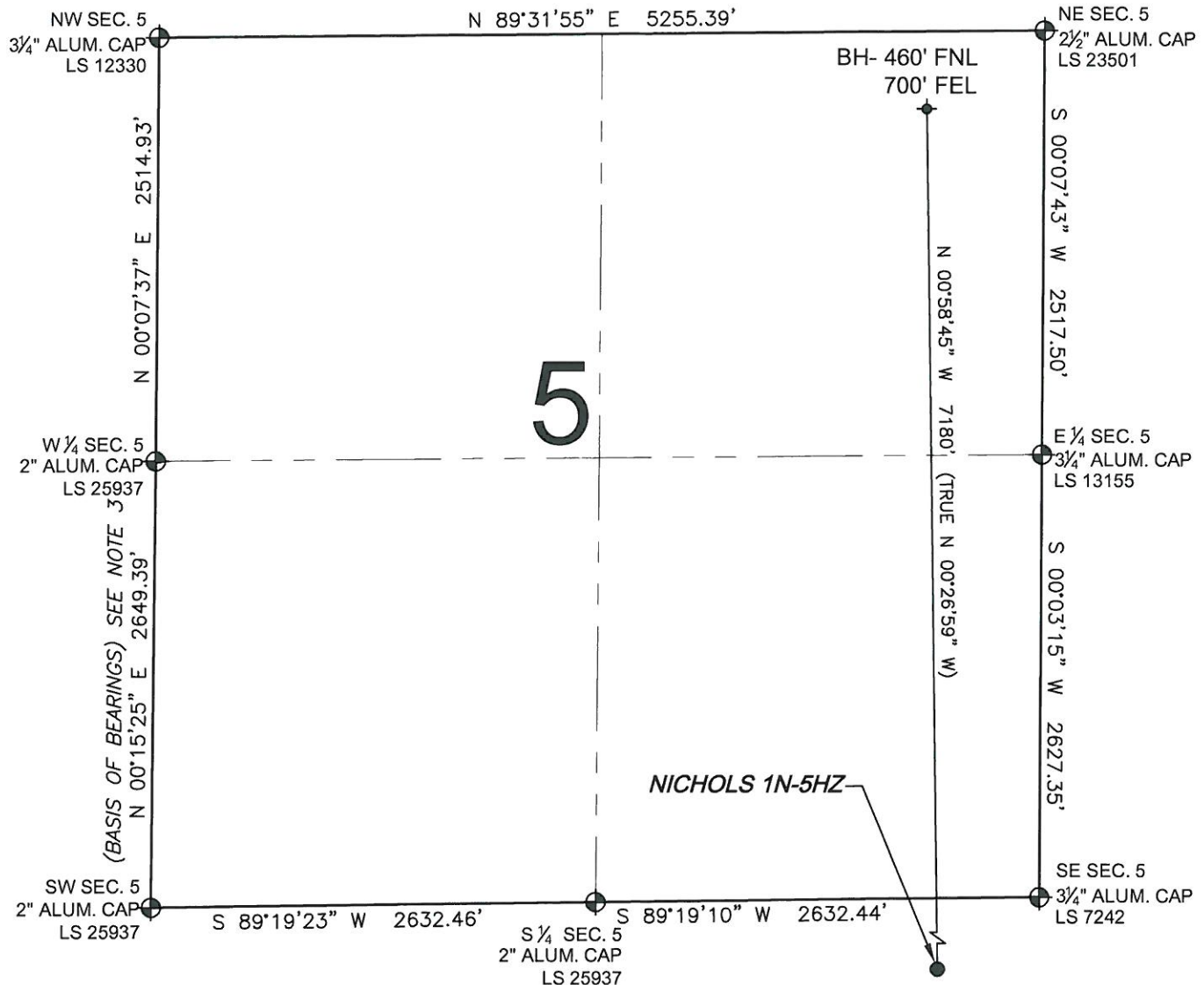
