On April 4, 2011, I visited the Ouray County Assessor's Office ("the Assessor") to ascertain property ownership information for the above-referenced location, which according to the Assessor, is a portion of the following parcel:

Colorado Oil and Gas Conservation Commission (COGCC) Rule 204 provides for access to all lands in the state for the purpose of inspecting oil or gas wells.

204. GENERAL FUNCTIONS OF DIRECTOR

The Director and the authorized deputies shall also have the right at all reasonable times to go upon and inspect any oil or gas properties, disposal facilities, or transporters facilities and wells for the purpose of making any investigation or tests to ascertain whether the provisions of the Act or these rules or any special field rules are being complied with, and shall report any violation thereof to the Commission.

However, COGCC is providing this notice as a courtesy to you, considering that lands near the Town of Ridgway are not active oil or gas producing areas.

We intend to inspect the Ashing Ranch #1 (API No. 05-091-05007) well and the Ashing #2 (API No. 05-091-05009) well locations to verify the current well status

for each location during the afternoon of Monday, October 17, 2011. According to COGCC's records, the both wells were drilled and completed in 1947 to total depths of 410 feet and 485 feet, respectively. The current status for both wells is listed as producing (PR), although there are no production records on file with COGCC.

If you have any knowledge related to the current status of the Ashing Ranch #1 well and Ashing #2 well, if you have a preferred route for accessing your property to inspect these wells, or if you no longer own this property, then please contact me at your earliest convenience prior to Monday, October 17, 2011.
