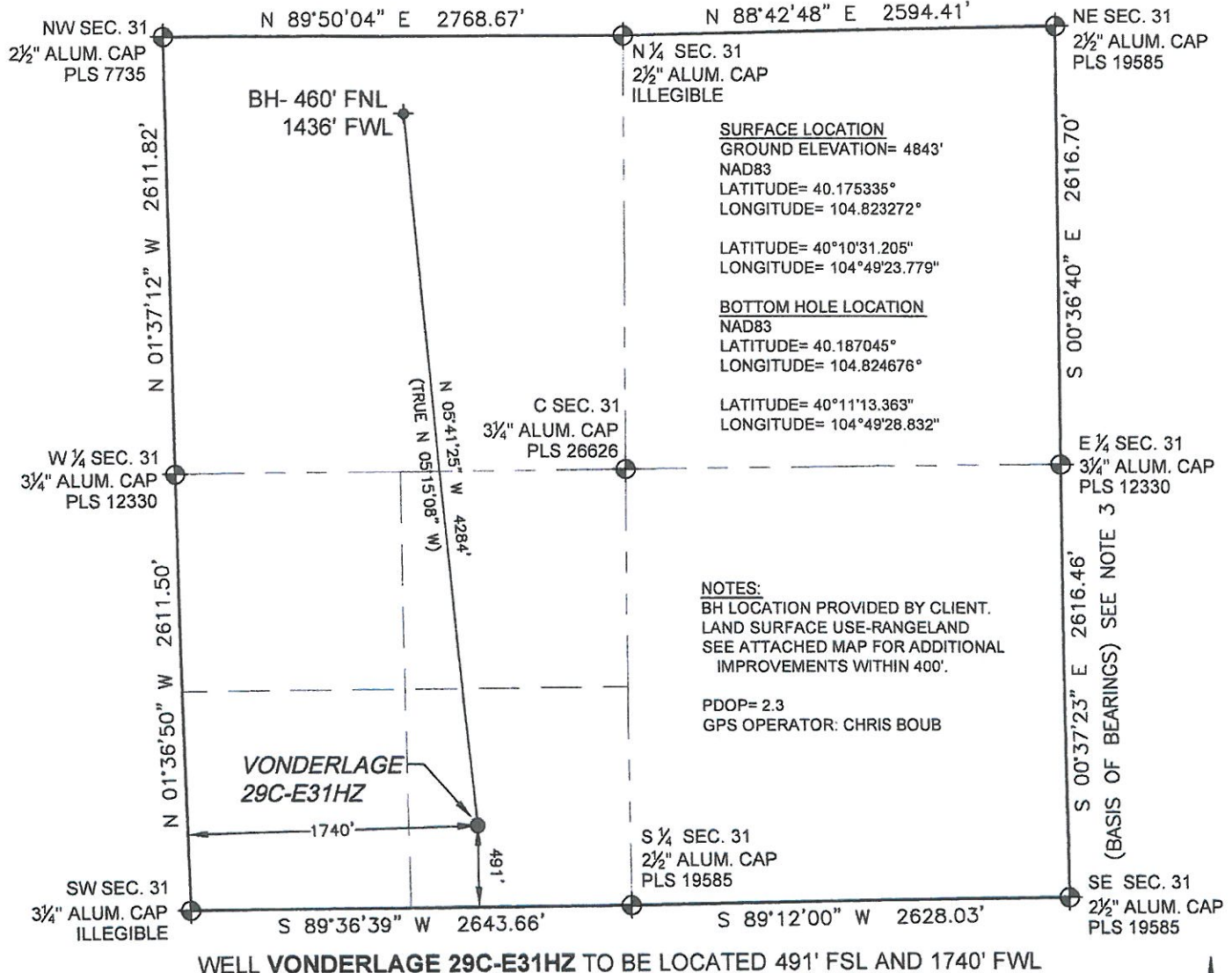


WELL LOCATION CERTIFICATE: VONDERLAGE 29C-E31HZ

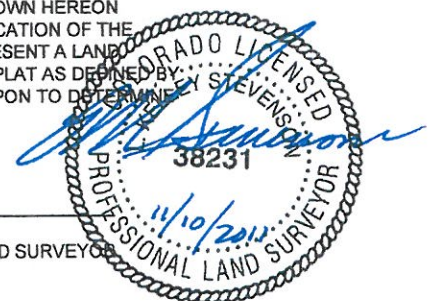
