Kerr-McGee Oil and Gas Onshore LP ("KMG") intends to begin operations to drill the above captioned oil and gas well(s) upon approval of title, receipt of permits from the COGCC prior to September 30, 2012. As the surface owner, it is your responsibility to notify the tenant farmer, if applicable, of this proposed operation.
