Dear Ms. Gurtler:

Encana Oil & Gas (USA) Inc. ("Encana") staked the Gurtler 2A-30H well at a surface location 210 feet from the north line and 868 feet from the west line of Section 30, Township 2 North, Range 64 West (see attached survey plat). This well is being drilled under the rules and regulations of the Colorado Oil and Gas Conservation Commission's ("COGCC") Rule 318A known as the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule. This rule states that all boundary infill wells be drilled from the same surface locations as previously designated in Rule 318A.a.(1) which reads:

"In the Greater Wattenberg Area ("GWA"), operators may utilize the following described surface drilling locations (GWA windows") to drill, twin, deepen, or recomple a well (GWA well") and to commingle any or all of the Cretaceous Age formations.

(1) A square with sides four hundred (400) feet in length, the center of which is the center of any governmental quarter-quarter section ("400' window"); ...

The Gurtler 2A-30H well was staked at a location 254' north of the defined 400' window. As this location was staked with your consent and approval, Encana respectfully requests your consent to an exception location for the Gurtler 2A-30H well by waiver of the COGCC Rule 318A.a (1).



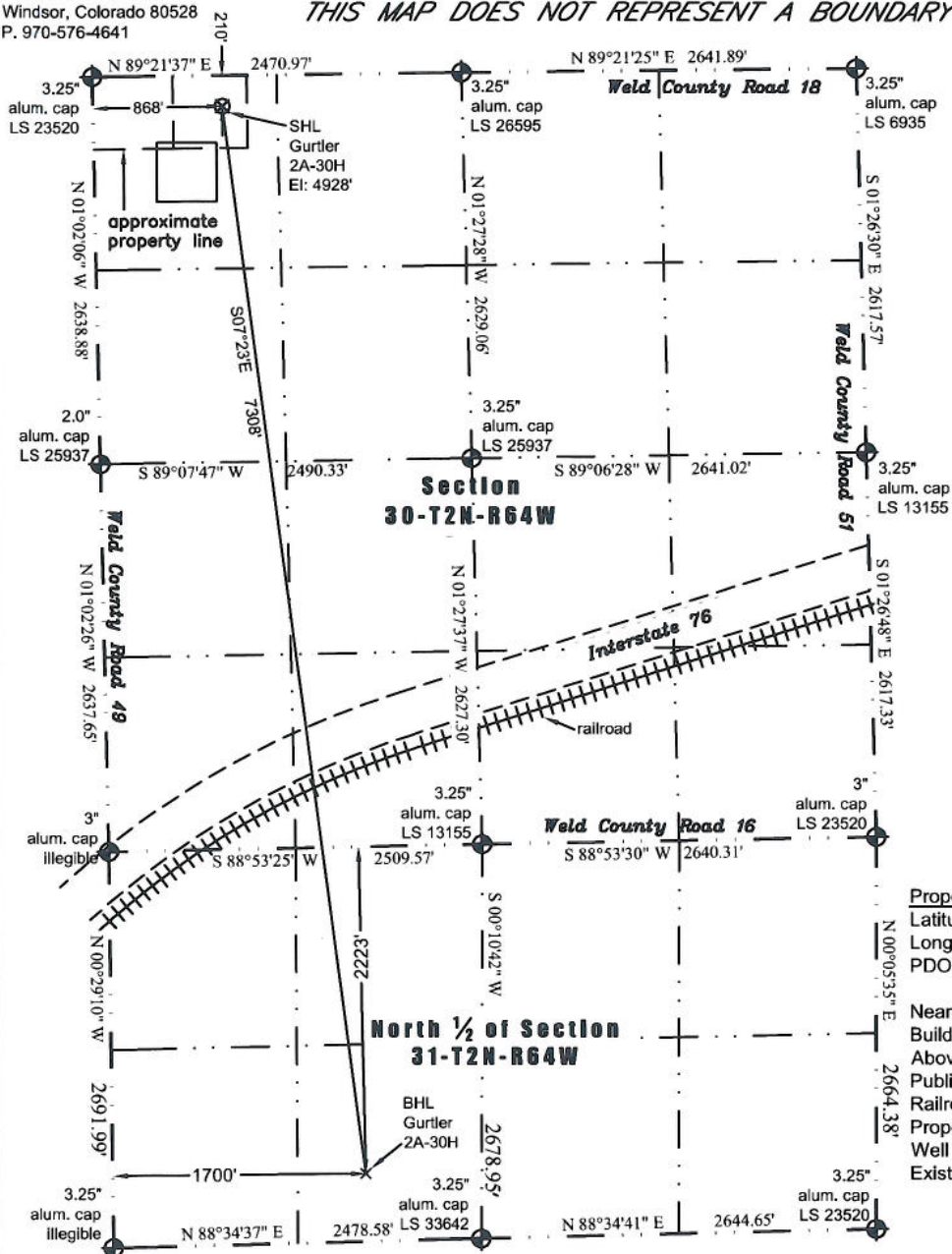
