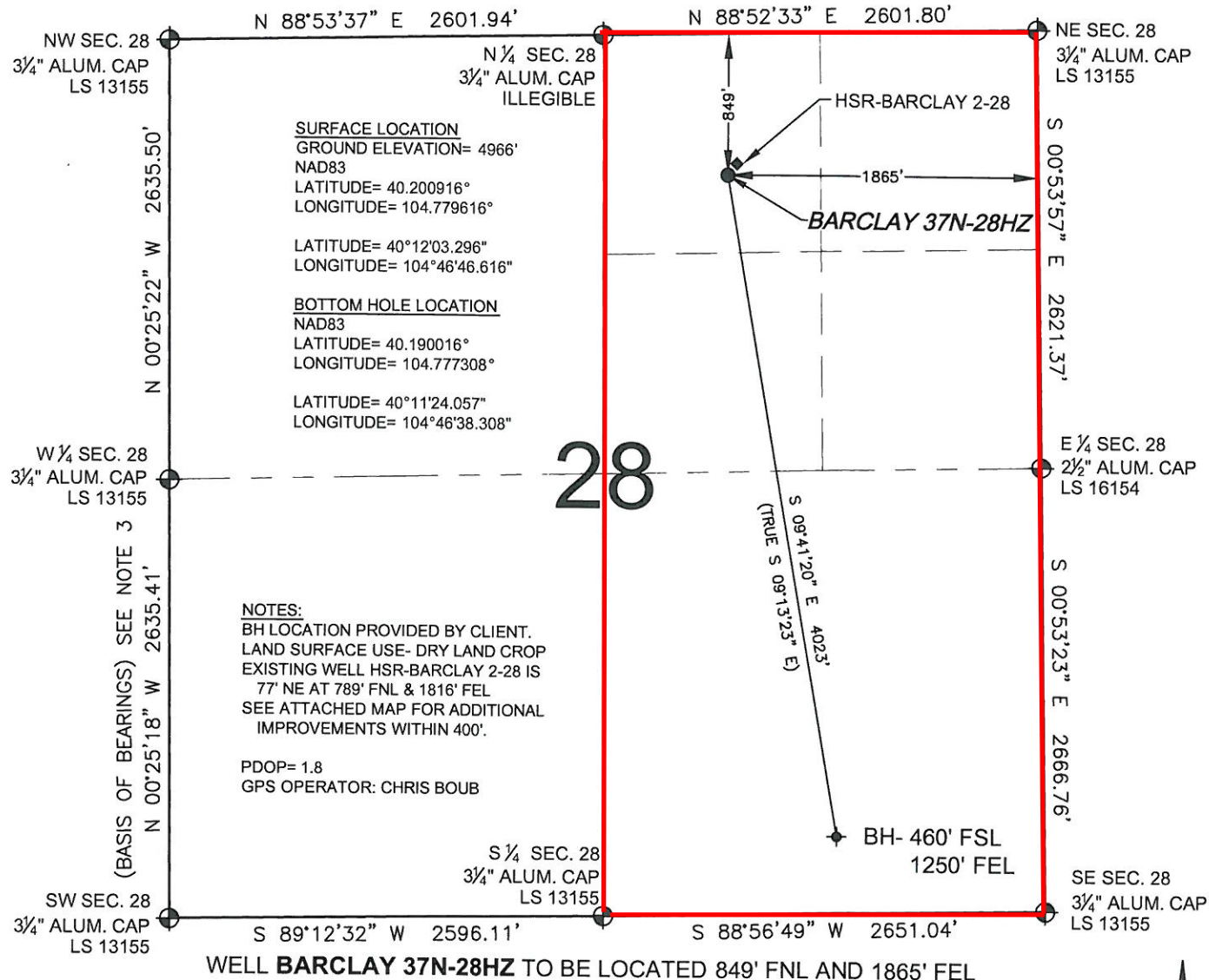

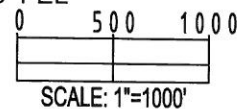
WELL LOCATION CERTIFICATE: BARCLAY 37N-28HZ
