This letter documents our discussion regarding the above-referenced Oil and Gas Facility located within the NWNW 36, Township 26S, Range 67W, Huerfano County.

Pursuant to COGCC Rule 306.c (consultation with CDOW) and 1202.b (oil & gas location on SWHA), and based on the presence of a **Pronghorn antelope winter concentration area**, CPW has consulted with you on the above-referenced facility.

Natural Resources Group, Inc. is aware that the site lies within a Pronghorn antelope winter concentration area and CPW's recommended stipulation to the COGCC is to avoid development January 1-March 31.

CPW previously consulted on this well on 7/31/2009 with Mr. Dwayne Bacon at Energy Oil and Gas, Inc. Mr. Bacon accepted the stipulation then, as has Natural Resources Group, Inc. at this time. Therefore, CPW will recommend expedited permit approval to the COGCC.
