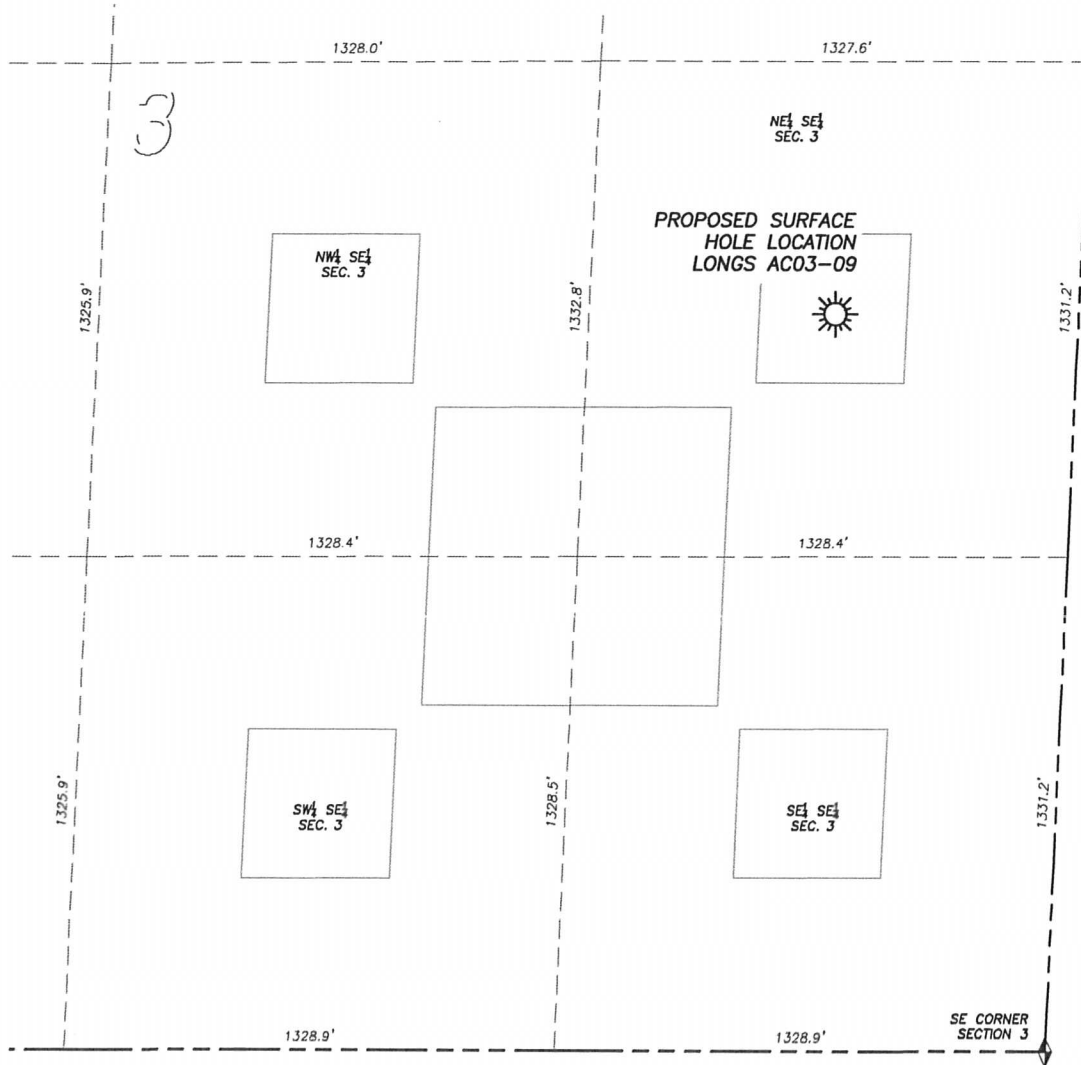

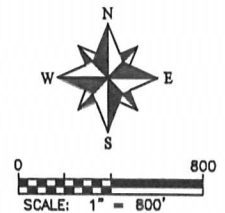
SITE SKETCH LONGS AC03-09
