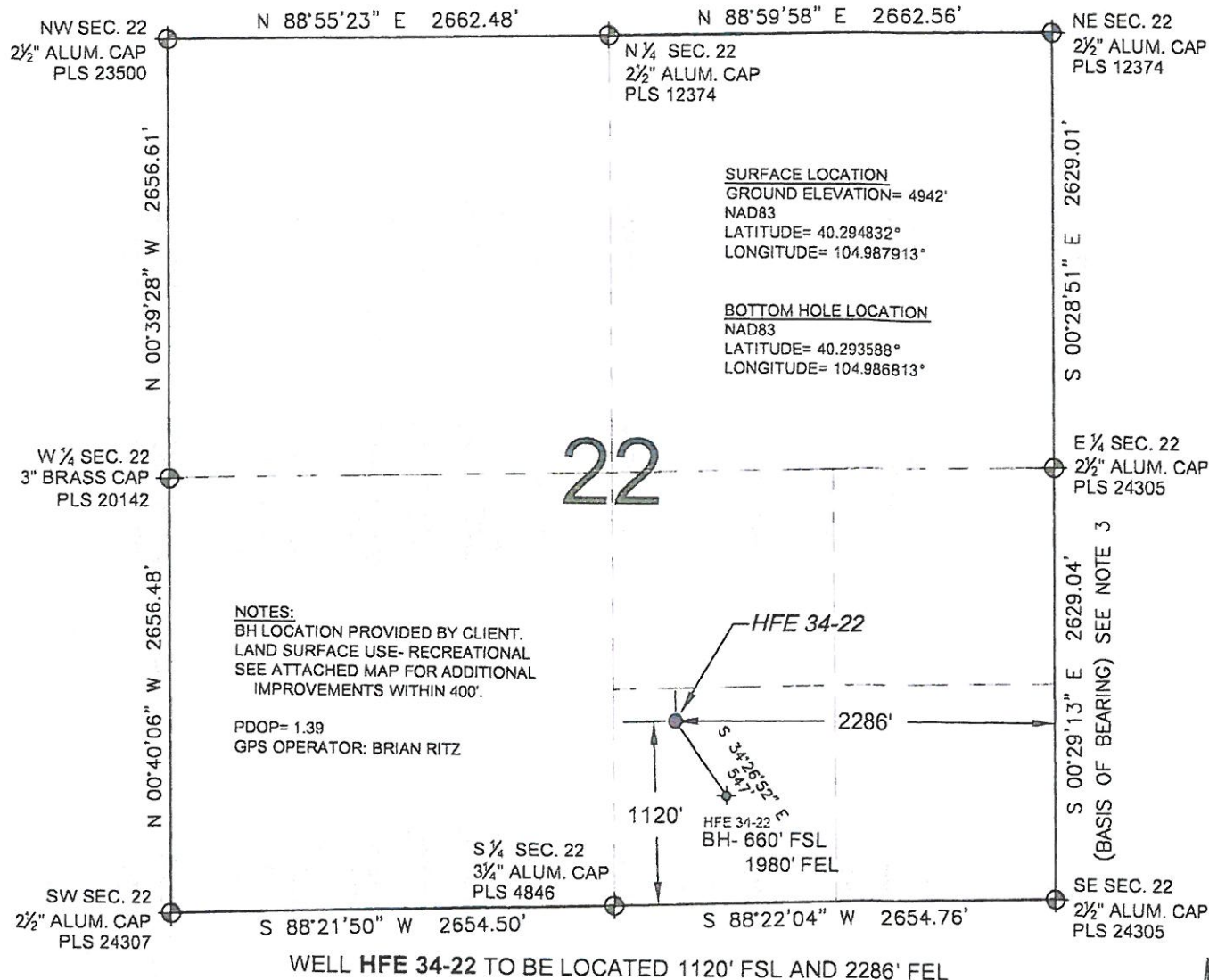


WELL LOCATION CERTIFICATE: HFE 34-22

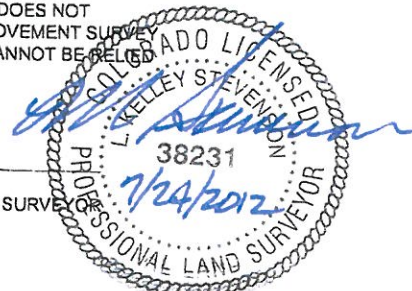
