Chris (Hines),

I have reviewed the Form 27 (for the 6 pits) and the NOC for J25W on behalf of Chris Canfield. Form 27s have been approved and uploaded to the database. Amber will generate remediation numbers and will copy you. Please use the REM # in future communications related to these pit closure projects.

**J25W:**

**Based on review of data presented, it appears that no further action is necessary at this time at this site. However, should future conditions at the site be discovered of contaminant concentrations in soils exceeding COGCC standards or if groundwater is found to be significantly impacted, COGCC may require that further investigation and/or remediation be conducted.**

No Further Action is necessary for J25W. As soon as I get the REM # for that pit closure project, I will send you a NFA letter. For the time being, please consider this email a confirmation of NFA for J25W.

**Note:**

**This is a reminder that COGCC strongly recommends to take discrete samples at the bottom of the pit,**

and not composite samples (composites are appropriate for stockpiles, land farming, etc.).

In the case of J25W, BTEX and TPH were ND, and therefore it can be inferred that there was no impact beneath the liner (even if it was a composite sample). In a case where the composite sample TPH concentration is, let say 450 mg/kg, it is not evident that all grab samples had concentrations below COGCC limits.
