Attachments required with a Subsequent Report are a wellbore diagram showing plugs that were set and casing remaining in the hole, the job summaries from all plugging contractors used, including wireline and cementing (third party verification) and any logs that may have been run during abandonment.

- 1) Provide 48 hour notice of MIRU to Mike Hickey at (970) 302-1024.
- 2) Based on adjacent water wells, cement coverage is required from 860' to at least 50' within the surface casing. This balanced stub plug shall replace the proposed plug half in and half out of the surface casing. This plug shall also be tagged if not brought to surface and it must be 605' or higher.
- 3) Provide an "As Plugged" wellbore diagram identifying the specific plugging completed.
- 4) If unable to pull casing contact COGCC for plugging modifications.
- 5) Properly abandon flowlines as per Rule 1103.
