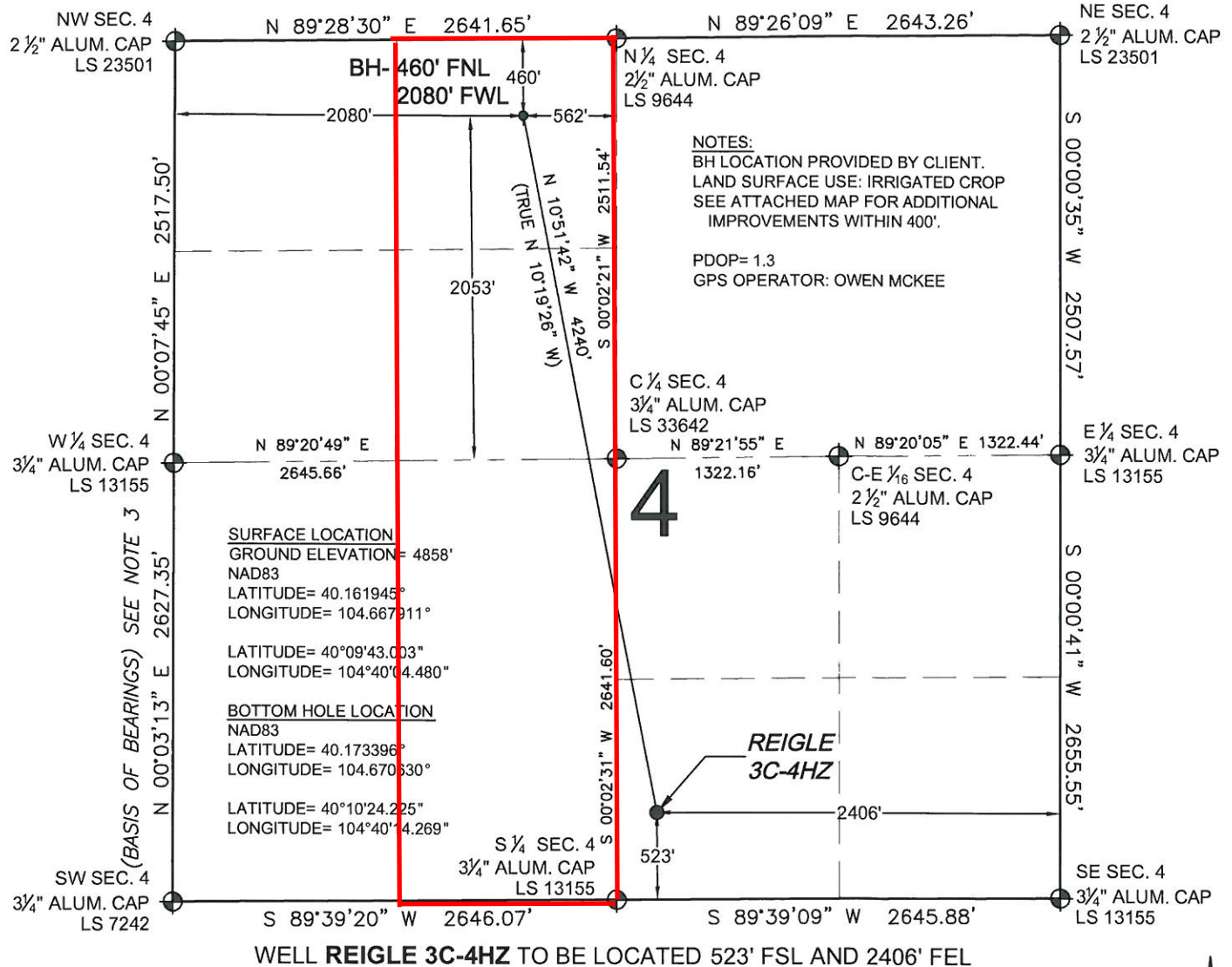

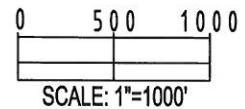
WELL LOCATION CERTIFICATE: REIGLE 3C-4HZ
