Gentlemen,

Tekton Windsor, LLC (TW) is applying for a permit to drill the above referenced well with the described surface location on property neighboring yours. Rule 603.a(2) of the Colorado Oil and Gas Conservation Commission (COGCC) stipulates that the surface location of a well must be no less than 150' from a property line. As planned above, the closest well is 84' from your property line. Per COGCC Rules TW is required to get surface owner approval of this location and a waiver of rule 603.a(2) from the affected offset surface owner.

The well is spotted as above in order to minimize surface disturbance while complying with your wishes and the Surface Use Agreement.
