DESCRIBE PROPOSED OR COMPLETED OPERATIONS

**SG 313-27 (API 05-045-21003)**

- This is a newly drilled well that has recently been completed (6/8/2012)
- Top of cement was called at 2,490'
- Cement top on the production casing did not cover 200' above the geologist's pick for the Mesa Verde top (2,427')
- Cement did cover the geologist's pick for the top of gas (3,826')
- Cement top did cover all the zones that we have an interest in completing, top perforation is 3,835'
- Observed Bradenhead pressure 161 psi.
- The Low TOC was communicated to the state and approval to continue with completion operations was given.

WPX requests permission to run a hard line to a tank to vent the bradenhead pressure for 90 days. In the meantime, remediation procedures will be generated in case at the end of the 90 days additional action is required.
