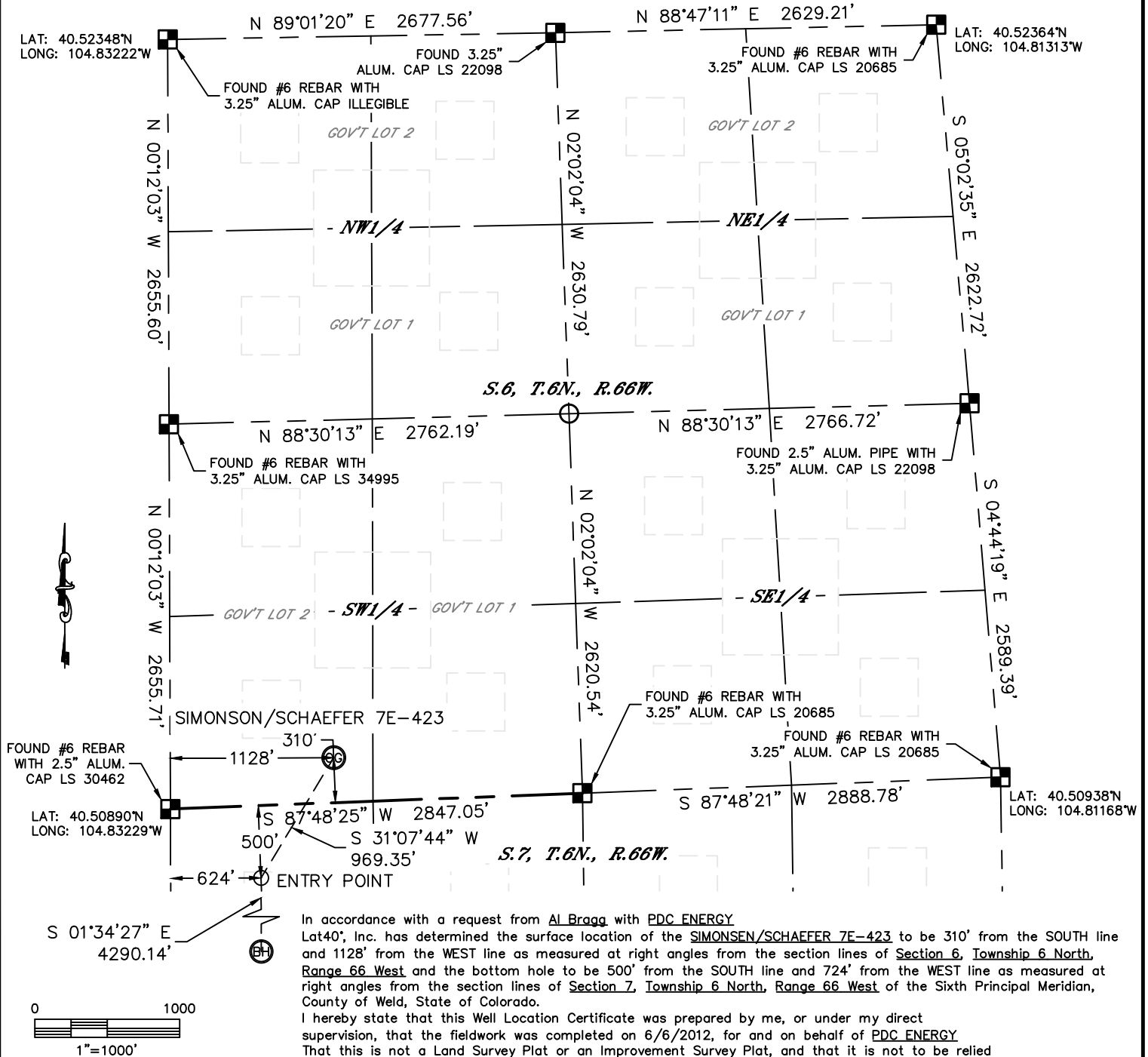


WELL LOCATION CERTIFICATE

In accordance with a request from Al Bragg with PDC ENERGY, Lat40', Inc. has determined the surface location of the SIMONSEN/SCHAEFFER 7E-423 to be 310' from the SOUTH line and 1128' from the WEST line as measured at right angles from the section lines of Section 6, Township 6 North, Range 66 West and the bottom hole to be 500' from the SOUTH line and 724' from the WEST line as measured at right angles from the section lines of Section 7, Township 6 North, Range 66 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 6/6/2012, for and on behalf of PDC ENERGY. That this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future improvement lines.
