


WELL LOCATION CERTIFICATE: RUSSIAN FIDDLER 37N-18HZ

SECTION 19, TOWNSHIP 2 NORTH, RANGE 65 WEST, 6TH P.M.




WELL RUSSIAN FIDDLER 37N-18HZ TO BE LOCATED 335' FSL & 2463' FEL.






