Technical Detail/Comments:

Cheyenne rig 17 mistakenly rigged up on this well and drilled the surface hole to a depth of ~205' before realizing their mistake. There is 90' of conductor in place, so ~115' feet of surface hole was present below the conductor. The rig was skid to the correct location, and the surface hole at the 697-05-59D was abandoned by pumping 107 sacks of Pre "G" with 10#/sk Cal Seal and 2% Calcium chloride, mixed at 15.0 ppg with a yield of 1.41.

Nor futher work or drilling has occurred at this well, and Oxy has no plans to re-enter and continue drilling this well.

The conductor will be filled with Redimix cement to plug and abandon the conductor.
