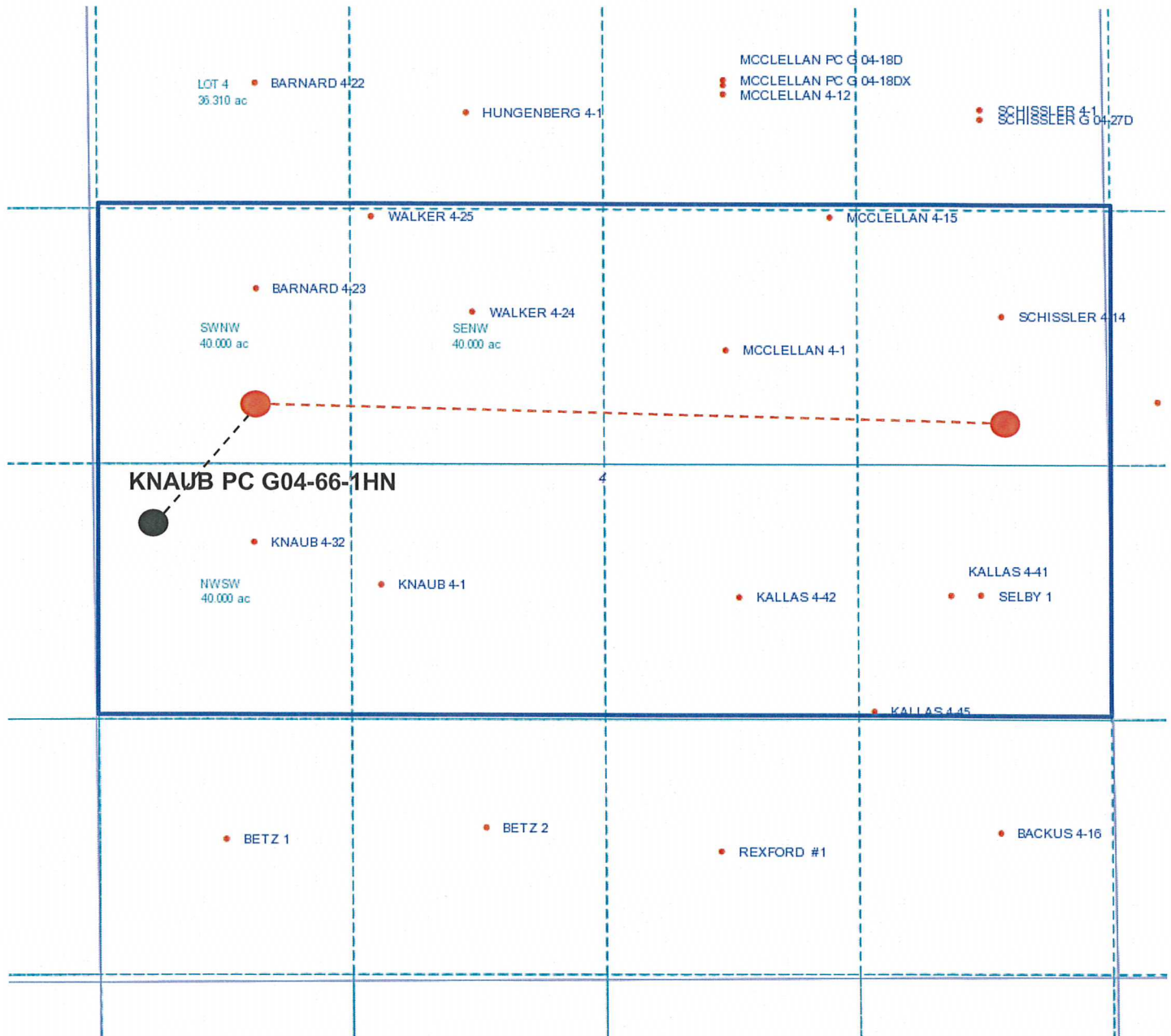

Bottom Hole Location

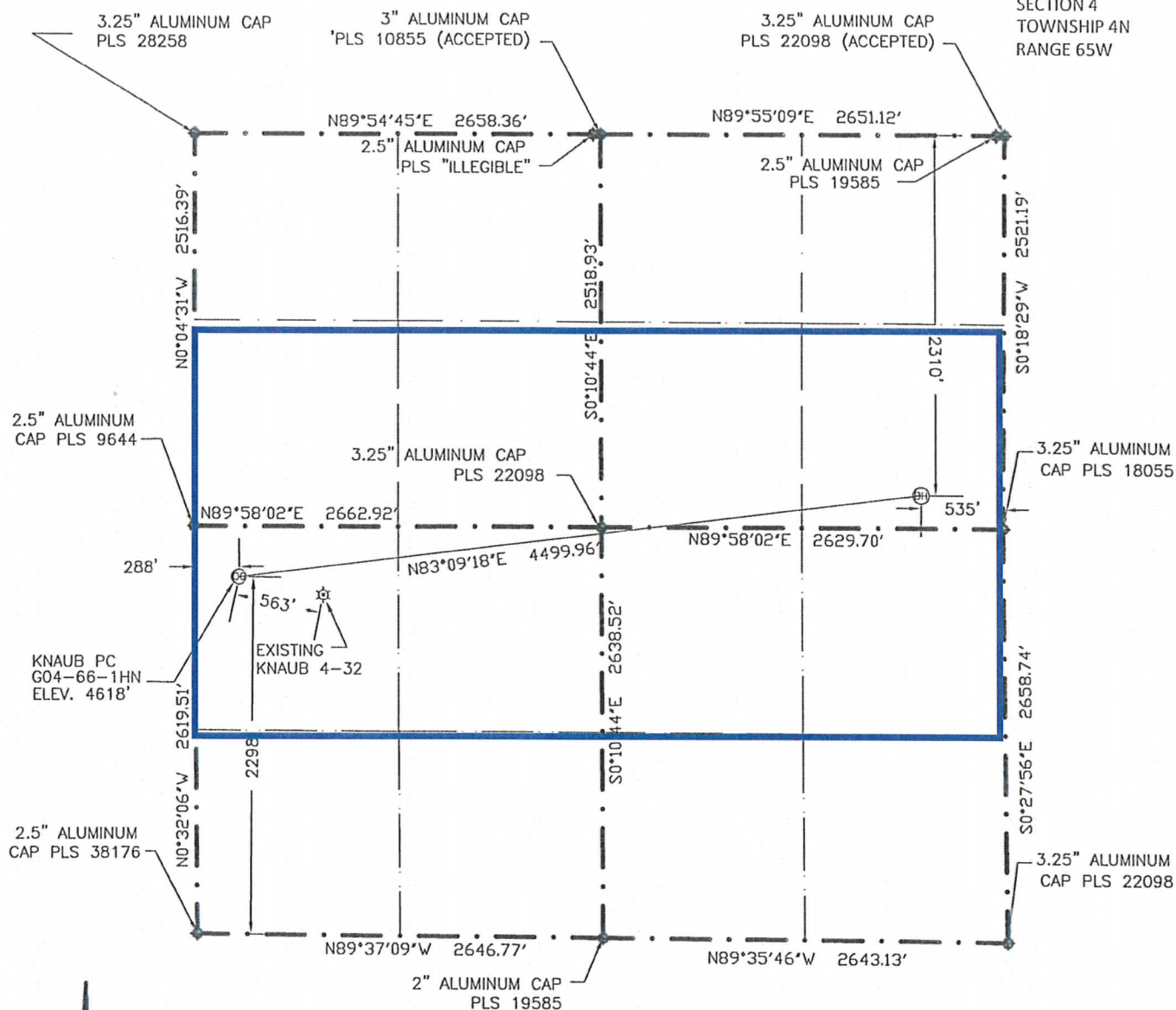

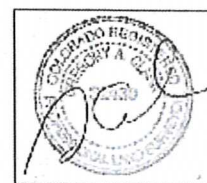
