On April 20, 1992, the Commission adopted Rule 127, into the Rules and Regulations of the Oil and Gas Conservation Commission which allows tracts of land to be designated as high density areas upon application, notice and hearing before the Commission.
On August 9, 1993, Park Lake Homeowners Association filed with the Commission an application for an order to establish the lands in the Park Land Estates consisting of the W $\frac{1}{2}$ NW $\frac{1}{4}$, N $\frac{1}{2}$ SW $\frac{1}{4}$, and SW $\frac{1}{4}$ of Section 29, Township 1 North, Range 69 West, 6th P.M., Boulder County as a high density area.
