NOTICE OF HEARING BEFORE THE OIL AND GAS CONSERVATION COMMISSION OF THE STATE OF COLORADO CAUSE NO. 1 DOCKET NO. 0212-GA-09 IN THE MATTER OF A REQUEST FOR AN EXTENSION OF TIME TO PERFORM WORK REQUIRED OF MONUMENT GAS MARKET- ING, INC., KIOWA COUNTY, COLORADO TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

On September 23, 2002 the Commission issued Order No. 1V-238 which found Monument Gas Marketing, Inc. ("Monument") in violation of Rule 319.a.(1) for the Bucklen #2-34 Well, located in the SW1/4NW1/4 of Section 34, Township 17 South, Range 46 West, 8th P.M. Monument was ordered to re-enter the Bucklen #2-34 Well and properly plug the well no later than February 1, 2003.

On October 24, 2002, Monument Gas Marketing, Inc. filed with the Commission a Motion to Reconsider to either amend or repeal the subject Order No. 1V-238 and find that Monument is not in violation of Rule 319.a.(1) for the Bucklen #2-34 Well. Monument is prepared to offer testimony from seven witnesses, to submit logs and cross-sections of numerous wells showing that Monument plugged the Cheyenne and other aquifers properly, and to submit COGCC approved plugging procedures on surrounding wells.

NOTICE IS HEREBY GIVEN, that the Oil and Gas Conservation Commission of the State of Colorado, pursuant to the above, has scheduled the above-entitled matter for rehearing on:

Pursuant to said hearing in the above-entitled matter at the time and place aforesaid, or at any adjourned meeting, the Commission will enter such orders as it deems appropriate to protect the health, safety and welfare of the public and to prevent the waste of oil and gas, either or both, in the operations of said field, and to carry out the purposes of the statute.

In accordance with Rule 509., any interested party desiring to protest or to intervene should file with the Commission a written protest or a notice to intervene no later than November 18, 2002 briefly stating the basis of the protest or intervention. Such interested party shall, at the same time, serve a copy of the protest or notice to intervene to the person filing the application. An original and nine (9) copies shall be filed with the Commission.
