Mary: I visited the site on 10/19/2012. And have no issues on site location. When the pad is constructed, I am be requesting that the top 6" of soil be removed and stockpiled for future reclamation. During pad construction down slope erosion control Berms should be constructed to prevent sediment from leaving pad site and impacting the water pond NE of proposed pad. Pad site needs to be fenced to prevent cattle from accessing site. Fence with 16' line spacing + corner posts a minimum of 6" in diameter buried 3' deep. I understand field is not presently grazed but future is may change.
